Sub: Seeking information on Teacher Education Institutions: Reg

Sir/Madam,

As you are aware, NCTE is a statutory body functioning under the NCTE Act, 1993 to bring about planned and coordinated development of teacher education in India. NCTE's statutory functions include the maintenance of norms and standards in Teacher Education Institutions (hereafter TEIs). Towards this end, the NCTE embarked on a drive to obtain data on essential regulatory parameters from all TEIs in the form of Performance Appraisal Report (PAR) through a public notice dated 22nd September, 2019. Through this notice we directed all the TEIs to file details through an online method within a given time period. The process of filling up this PAR started on 23rd September, 2019 and ended on the midnight of 21st January, 2020.

2. PAR is a mandatory requirement expected from all TEIs. Unfortunately, a number of TEIs did not fill up PAR. We are sharing a list of institutions in your State which have not filled up PAR and would request the following information to be furnished as regards the TEIs within your jurisdiction: -

a. Whether your University/ SCERT grants affiliation to TEIs? If so, which of the institutions mentioned in the list have been granted affiliation by you?

b. If you are an affiliating body, are you aware that the NCTE has prescribed norms and standards for the conduct of teacher education programmes and also that the TEIs are expected to be compliant with the same at all times.

c. Whether these institutions are actually running Teacher Education Programmes within the jurisdiction for which you have granted affiliation?

d. Whether any inspection as required under your Statute / Rules has been conducted since 1st January, 2019 till date? If, yes then the inspection report may please be shared.

3. Considering that the new Academic Session will begin in few months time, it is necessary that all Affiliating Bodies may kindly **respond urgently** to the questionnaire through online method at: ***mail@ncte-india.org***
