- 2) M. A. Economics / M. Com. / M.B.A. (Finance) and Ph. D.

**B) Areas of Specialization :**

- 1) Research in Policy evaluation.
- 2) Encouraging and developing inter disciplinary research.
- 3) Devising entrepreneurship development programs.
- 4) Research regarding issues in rural banking.

**C) Desirable Qualification :**

- 1) Person with research publications books (both in English and Marathi) / edited volumes and textbooks will be given preference.
- 2) The applicant's professional achievements will be given favorable consideration.
- 3) The applicant must be conversant with Interdisciplinary approach and must have earlier work done in the form of publications / conference / seminars in the field of Banking / Economics / Commerce / Management.

The initial tenure of the incumbent of the chair professor is one year. Subsequently it may be extended for two more years depending on academic performance.

- 6) Devising entrepreneurship development programmes and skill development programmes with emphasis on small scale industries in rural areas.
