Under section 74(4) of the Maharashtra Public Universities Act, 2016 the Hon'ble Chancellor, vide his office letter No. CS/Shivaji/ORD/2019/CR-157/407 dt.20/03/2020 has accorded assent to the amendment to the Ordinance No. O.78 regarding Dual Degree Program.

## 0.78

A student can pursue two programs simultaneously through distance or combination of distance and regular modes from the same or different University(ies) / Institution(s) in various combinations *viz*.

- 1. One Degree and one Diploma/Post-Graduate Diploma/Certificate
- 2. One Post-Graduate Diploma and One Diploma/ Certificate
- 3. One Diploma and / One Certificate
- 4. Two Post-Graduate Diplomas
- 5. Two Diplomas
- 6. Two Certificates

In any case two Degree Programs cannot be allowed to be pursued simultaneously.

A student willing to keep terms for two programs shall apply to the Distance Education Centre of the University with proofs of regular admission and detailed information about second program which student wants to complete.

All such applications shall be scrutinized by the Distance Education Centre and such applications with the combinations, which are not affecting examination schedule of the University, shall be approved. In case of any overlap /clash between the examination schedules of the two examinations on account of any change in any of the schedule made by the University, it shall be the discretion of the student to appear for the examination of his/hir choice. Any complaint /request in such matter for change in the examination schedule shall not be entertained by the University.

This is an additional facility provided to students and shall not be treated as a right.
