

1. All the above selected candidates are required to complete their Eligibility procedure on or before 28-02-2025.
2. You need to bring 3 Xerox sets of all your relevant educational documents and testimonials.
3. The List of documents to be carried in 3 sets are as under:
 - a) Online Application Form (3 Sets)
 - b) Aadhar Card Xerox (3 Sets)
 - c) Voter ID Xerox (3 Sets)
 - d) 5 ID Size photographs along with its pocket to be pasted inside the office file.
 - e) One simple Office File (not plastic file / folder)
 - f) Marks Statement and Passing Certificates of SSC (X) passed Examinations (3 Sets)
 - g) Marks Statement and Passing Certificates of HSCE (XII) passed Examinations (3 Sets)
 - h) Marks Statement and Passing Certificates of Graduation Degree Examinations (if Applicable) of all the Semesters. (Sem I, II, III – Marks Sheets and Passing) (3 Sets each)
 - i) Convocation Degree Passing Certificate of Graduation Degree (If Applicable) (3 Sets)
 - j) Marks Statement and Passing Certificates of LL.B. Examinations (3 Year LLB or 5 Year LLB) (3 Sets) and Marks Sheets of All the Semester (Sem I, II, III, IV, V, VI in case of 3 Year LL.B and Sem I, II, III, IV, V, VI, VII, VIII, IX, X in case of 5 Year LL.B.
 - k) Convocation Degree Certificate of Final Year LL.B. (3 Sets)
 - l) Marks Statement and Passing Certificates of LL.M. (Master of Laws) Degree of all the Semesters (Sem I, II, III, IV, V & VI) (3 Sets)
 - m) Convocation Degree Certificate of Final Year LL.B. (3 Sets)
4. You are required to bring one separate simple Office File (Not plastic files / folders).
5. You are required to carry 5 copies of ID size Photographs.
6. You are required to collect Eligibility Form which is in red colour from the Extension Building right behind the Main University Building.
7. This Eligibility form is required to compulsorily to be filled with black ink only.
8. You need to paste your photograph at a relevant place on the Eligibility Form.
9. The Fees to be paid for Eligibility is Rs. 150/- for Home University Students and Rs. 300/- for Other University Students.
10. After collecting the Eligibility Form and after duly filling the same and signing on it, the students are required to take the signature and stamp of the Head with remark of fees to be paid on it.
11. The Fees are to be paid at Room No. 107 (Cash Section) of the Main Building towards the left hand side on the ground floor and at the extreme end of the Main Building.
12. After payment of Fees the Eligibility form along with the Department copy of the Fee Receipt are required to be submitted to the Department of Law.
13. Please don't forget to bring 3 sets of online application form copies that you had submitted at the time of completing the Entrance form procedure.
14. After completion of the Eligibility Application formalities, all the candidates will be issued with Provisional Admission Certificate from the Head of the Department. Kindly Collect the same from the office.
