संलग्न महाविद्यालये तसेच शिवाजी विद्यापीठातील विविध पदव्युत्तर अधिविभाग येथे नियमित प्रवेश घेतलेल्या विद्यार्थ्यांसाठी, दुहेरी पदवी ;कंस कमहतममद्ध घेण्याची संधी शैक्षणिक वर्ष 2007-2008 पासून उपलब्ध करून देणेत आली आहे. महाराष्ट्र विद्यापीठे कायदा 1994 मधील तरतूदीनुसार दंडक 78 अन्वये दुहेरी पदवी योजना राबविण्याची प्रक्रिया सुरु केलेली आहे. या योजनेतील सर्व नियम व अटी दंडक 78 प्रमाणे राहतील.

शिवाजी विद्यापीठ अंतर्गत नियमित अभ्यासक्रम प्रवेश घेतलेल्या विद्यार्थ्यांना दंडक 78 मधील तरतूदीनुसार कंस कमहतमम योजनेअंतर्गत एकाच वेळी त्यांच्या नियमित अभ्यासक्रमाबरोबरच बहिस्थ अभ्यासक्रमास प्रवेश घेऊन एक नियमित व एक बहिस्थ पदवी पूर्ण करता येईल. दुहेरी पदवीच्या नाव नोंदणीसाठी विद्यार्थ्यांनी रु. 1000/-फीसह प्राचार्यामार्फत/ अधिविभागप्रमुख यांच्या सही शिफारस सह विहित मुदतीत अर्ज शिवाजी विद्यापीठाच्या पात्रता विभागाकडे पाठवावेत. (अर्जाचा नमुना विद्यापीठाच्या संकेत स्थळावर (www.unishivaji.ac.in) येथे उपलब्ध करण्यात आला आहे.) तसेच सर्व महाविद्यालयांना या परिपत्रकासोबत उंपस व्दारे पाठविण्यात येत आहे. दुहेरी पदवीचे शुल्क विद्यापीठ कार्यालयात कार्यालयीन वेळेत भरणे आवश्यक आहे. अथवा रु.1,000/- डिमांड ड्राफ्ट वित्त व लेखा अधिकारी, शिवाजी विद्यापीठ, कोल्हापूर (चलंइसम ज ज्ञवसीचनत) यांचे नावे पाठवून देणे आवश्यक आहे. या अर्जाची छाननी नियमाप्रमाणे विद्यापीठाच्या अधिष्ठाता समिती मार्फत करण्यात येऊन पात्र विद्यार्थ्यांची नावे महाविद्यालये व दूरशिक्षण विभाग यांना कळविण्यात येतील. दुहेरी पदवीस अर्ज करणा-या विद्यार्थ्यांनी विहित मुदतीत बहिस्थ विभागात प्रवेश घ्यावा तसेच दूरशिक्षण केंद्राअंतर्गत असणारे अभ्यासक्रम यांच्या नियमांप्रमाणे असणारे विहित शुल्क व अर्ज भरण्याची कार्यवाही करावयाची आहे. दूरशिक्षण अंतर्गत उपलब्ध अभ्यासक्रमांची यादी व पात्रता सोबत जोडली आहे. संबंधित विद्यार्थ्यांनी त्याप्रमाणे पात्रतेची अट विचारात घेऊनच अर्ज सादर करावयाचे आहेत.
