Rules for the Award of Research Grants to Teachers of Colleges which are not covered under Section 2(f) & 12 (B) of UGC Act

- 1) The University may constitute a Research Grant Committee under Section 80 of the Maharashtra University Act. 1994 to consider the proposals received under the scheme.
- 2) Teachers seeking research support under this scheme are required to submit al fully worked out research proposal through proper channel before July 31 of every year and only such proposals shall be accepted and such proposals shall be accepted and screened by the Research Grant Committee.
- 3) The age limit for application of this grant is 50 years
- 4) Topic of Research proposal should not be related to M.Phil or Ph.D topic.
- 5) University may provide financial assistance up to Rs. 25,000/- or actual expenditure whichever is less for the college teachers for research in Science, Humanities including Language and Social Sciences in two installments as mentioned below:
 - (i) 50% at the time of sanction
 - (ii) 50 % on Submission of final report on the basis of final expenditure
- 6) The period of research grant shall two years only.
- 7) Preference may be given to Associate Professor and Assistance Professor for undertaking research projects having good publications in the Scopus and / or research publications in the referred journals.
- 8) Research projects in collaboration with other agencies shall be preferred.
- 9) Teachers shall require to submit an undertaking in the prescribed proforma (copy enclosed) on a stamp paper of Rs. 100/- duly counter signed by the respective Principal
- 10) The date of beginning of the project shall be from the date of release of first installment of the grant

- 11) Since the tenure of the scheme will be for the period of two years, the payment against the bill of expenditure received from the teachers will be effected from the annual budgetary provisions immediately after the bills are received and without considering the specific annual component of the provisions.
- 12) Assets acquired under the funding shall be the property of the respective college after completion of the project. That should be entered in the accession register and dead stock register of the college.
- 13) Six monthly progress reports should be submitted (in duplicate) through proper channel. Report received after stipulated date will be liable for refund of the first installment paid to them. That will be evaluated by a subject expert committee after a period of one year (midterm evaluation). University shall take decision for continuation of the project/ modification of research direction on the basis of evaluation. The experts shall give clear recommendation.
- 14) Publication should be acknowledged to Shivaji University, Kolhapur.
- 15) Name of the Shivaji University should be mentioned in the address of the Author on the title page.
- 16) The teachers, who have been sanctioned the grant under this scheme, will be required to submit a work done report in triplicate, immediately after the tenure of the scheme is concluded.
- 17) Final research report shall be submitted in a soft copy along with one hard copy. The report shall be in the research paper format of any international journal, typed on both sides and in single spacing.
- 18) At least one research paper should be published in the referred Journal.
- 19) Project completed shall be assessed and graded by a duly constituted expert committee by the University.
