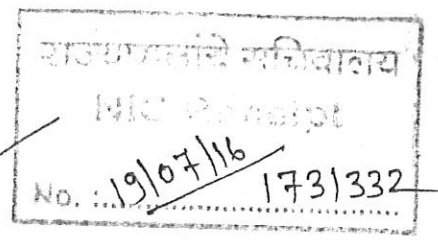

Sub : Shivaji University – Exam irregularities

Sir,

In the Shivaji University exams are conducting in a fraudulent manner almost in all the Departments.

Even 10 to 15 Percentage of students are attending the classes and the college and university departments are giving more than 75% attendance, allow them to appear for exam and giving first class or distinct with out quality. This year, LL.M Practical exams are not conducted as per syllabus. One assignment was given student and they have write and appear before two teachers. Every student got 18 to 19 out of 20marks. 95% students after enroll not turn up to their fact to the class or department and straight away appear for exam. In assessment out of 80 student score more than 70 to 74 marks as it is really a shame to University and to the State.

Please issue an ordinance requesting to all the college and the University to strictly implement students Bio Metric and fix cc tv camara to know where as classes are going or not. Many colleges are appointing only 6 month and show the record full time CHB. Make all private and aided institution payment through Bank account via State Govt. to protect the teaching faculty. Most of the aided class teachers are not taking the classess. Students now a days preparing MPSC/ NET SET and working company and private shop or institution. Regular admission on record but College or University function is zero.

Please look all these issues and make necessary step to save the higher education. Private institution primary/ Higher primary school or colleges charging and taking donation beyond imagination. In many places for admission to KG School they have to pay One lac donation and Rs. 50,000/- per year fees and colleges it is ranging 10 lac to 25 lacs. Strictly speaking Education collapsed to zero point.

Being a respectful chancellor it is your duty to protect and promote the Indian Education by taking serious steps to save the nation and generation.
