Whereas Maharashtra Public Universities Act, 2016 (Maharashtra Act No.VI of 2017) (here in referred to as "Said Act") has come into force from 1st March, 2017.

And

Whereas Section 34(2) of Maharashtra Public Universities Act, 2016 provides the faculties and in pursuance of this Government of Maharashtra has issued a letter vide No.Sankirna-2017/PRA-LRA-279/VISHI-3 Higher & Technical Education Department dtd. 22nd June, 2017 suggesting the merging of faculties with new four faculties under the Maharashtra Public Universities Act, 2016

And

Whereas, the statute 548 prescribing the nomenclature of Degrees under differenct faculties under the Maharashtra Public Universities Act, 1994 are inconsistent with the provisions of Maharashtra Public Universities Act, 2016 are deemed to the repealed

And

Whereas it is required to change/ restructure nomenclature of some of degrees as in accordance with Universities Grants Commission notification part III dtd. 5th July, 2014 notifying specification of degrees to be awarded by the Universities under different disciplines.

And

Whereas therefore the matter is required to be regulated by the Statutes and in the absence of the same for the time being issuance of the directions by the Vice-Chancellor u/s 12(8) of Maharashtra Public Universities Act, 2016 is necessary.

Therefore, I Prof. Dr. Devanand B. Shinde, Vice-Chancellor, Shivaji University, Kolhapur hereby regulate the matter by issuing following directions in exercise of powers conferred on me u/s12(8) of Maharashtra Public Universities Act, 2016.

The nomenclature of the degrees mentioned in column (2) shall changed to the nomenclature mentioned in column (3) of the following table :
