AICTE has issued a Public Notice for Approval Process 2018-19 which has been published in all leading newspapers. Accordingly, the portal was opened on 1st Jan, 2018 to enable the institutes to apply online. Details of the procedure regarding AICTE Approval are available in the AICTE Approval Process Handbook 2018-19. The same can be viewed / downloaded from the 'Approval Process 2018-19' link on home page of AICTE website (www.aicte-india.org).

In this connection, you are requested to apply online on the AICTE portal at the earliest. This time before applying for Extension of Approval (EOA) for the AY 2018-19, all the existing Institutions need to update/provide the

correct information related to the faculty data including AADHAAR & PAN of Head of the Institute (Principal/Director), Contact person, existing/new individual faculty, Enrollment and Quality Education Mandate Form on AICTE

portal (User Manuals available on Portal for Faculty Updation, Student Enrollment & Quality Education Mandate). Quality Education Mandate Form is applicable only for Engineering Colleges running UG Courses. The AADHAAR and PAN details of all the faculty members will be subject to verification and in case, if any information provided by the institution is found incorrect, then strict action (including withdrawal of Approval) will be taken against such institutions as per the provisions of Approval Process. Also, faculty members without/incorrect AADHAAR and PAN will not be considered as regular faculty while calculating faculty deficiency during grant of Extension of Approval for the academic vear 2018-19.

Only after completing updation of data related to Student Enrollment, Faculty Data and Quality Education Mandate (If applicable), all the existing approved institutions (in 2017-18) will be allowed to create application for Extension of Approval(EOA) for 2018-19 User Manual for applying for Extension of Approval 2018-19 is also available on AICTE Portal). In case of any portal /policy related issues, please send your grievance/query ONLY through Online Grievance Form which is available athttp://www.facilities.aicte-india.org/ApprovalPr ocess/apformEmail.php on AICTE Portal for quick response. Please note that, Grievance sent through Online Grievance Form ONLY will be entertained or considered for giving replay/clarification related to the queries.
