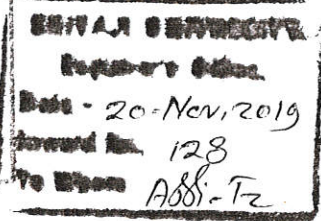
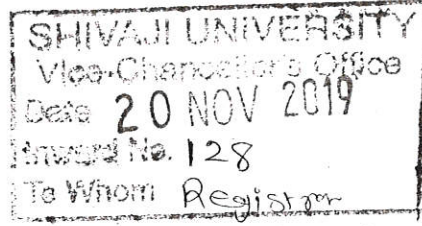

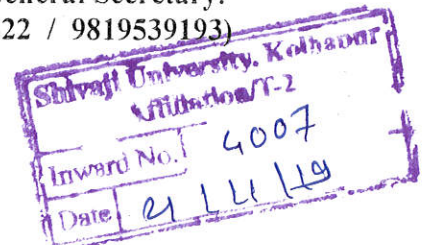

### State Level Inter Collegiate Elocution Competition for Degree Colleges.

#### RULES AND REGULATIONS

**Subjects :** Ten topics on the subject of DOWRY have been selected which are given on the reverse side of Rules & Regulations, will be placed on the table, participant has to pick up one card out of these 10 subjects and speak for 5 to 6 minutes.

**Day, Date & Time :** Sunday the 8<sup>th</sup> December 2019 at 10.00 a.m.

**Venue :** Sathaye College, Room No.7, Ground Floor, Dixit Road, Vile Parle (E) Mumbai - 57.

**Eligibility :** Degree Colleges (all faculties except B.Ed. & B.P.Ed. ) from Maharashtra State can participate by deputing TWO Students (preferably One Boy & One Girl Student) The names of the participants be submitted in the prescribed format as per the specimen enclosed duly certified by the College authorities to the effect that he / she is a bona fide student of the College. And should carry his / her Identity Card at the time of the Competition.

**Entry Form & Fee :** The prescribed Entry Form on prescribed format giving the details of the student representatives and ENTRY FEE of Rs.50/- be submitted to the above address on or before 7.12.2019. Entries will be accepted on 8.12.2019 at the venue as a very special case at 9.30 a.m.

**Language & Duration of the Speech :** The student participant may speak either in Marathi, Hindi or English and the duration of the speech will be five to six minutes. The participant will not be allowed to read out his / her speech but may however refer to the points written on a small piece of paper. **Competition will be held only if minimum 20 Colleges register their entries.**

**Prize Scheme :** RAJENDRA SHIELD will be awarded to the winning College. The student First in order of Merit will be awarded Lakshmidivi Bhishm Arya Trophy & Cash Prize of Rs.2500/- with Merit Certificate. There will be additional two Cash Prizes of Rs.1500/-, & Rs.1000/- to those who stand 2<sup>nd</sup> & 3<sup>rd</sup> in order of merit respectively. Certificate of Merit will be awarded to first ten in order of merit & Participation Certificate will be given to all.

**Evaluation:** The Evaluation will be on Individual basis and not on Team basis. The points of evaluation are : (1) Grasp of the Subject (2) Presentation of the Subject (3) Eloquence (4) Summarization & (5) Effect on the Audience.

**General Conditions :** The organization shall nominate a Panel of Judges to evaluate the competition and their decision regarding the Result of the Competition shall be final and binding on all concerned. The decision in respect of all the aspects of the competition shall be final & can not be questioned in any Court of Law or before any other Authority. The Result will be declared immediately after the Competition is over and Prizes will be awarded in a Special Function on 12.1.2020 at Sathaye College, Vile Parle (E) Mumbai.
