Dear Sir / Madam,

As per The Hon'ble Supreme Court of India in case of Bharathidasan University & Another Vs AICTE & Others has interpreted the provisions of the AICTE Act and has held that although university do not require prior approval of AICTE to commence a new department of course and programmes in technical education, however, universities have obligation or duty to confirm to the standards; and norms laid down by the AICTE. For the purpose of ensuring coordinated and integrated development of technical education and maintenance of standards, AICTE may cause an inspection of the university, which has to be as per the provisions under relevant rules/regulations of the AICTE. Further, all institutions running technical education programmes in collaboration with any university requires prior approval of AICTE. However, some of the Central / State / Private Universities are taking approval of AICTE for some selected Technical Courses / Programmes.

It is now decided by the Council that the Universities need to take approval to all the Technical Course(s)/ Programme(s) comes under the purview of AICTE being offered by the Universities otherwise the Council shall be constrained to stop giving approval obtained partially to only few Technical Course(s)/ Programme(s), as the approval obtained by the Universities for few courses creating confusion to the students who are taking admission in the Concerned Universities.

Dear Sir / Madam,

As Institution Deemed to be University need to take approval from AICTE (in compliance to the order dated 03.11.2017 passed by the Hon'ble Supreme Court Order CA No.17869-17870 /2017), hence, Institutions Deemed to be Universities offering Technical Course(s)/ Programme(s) shall not admit students without prior approval of the Council. It has been noticed that some of the Deemed to be Universities not yet taken approval from AICTE and some deemed to be Universities are taking approval of AICTE for some selected Technical Course(s)/ Programme(s) only.

It is therefore requested that the Deemed to be Universities have to take approval to all the Technical Course(s)/ Programme(s) from AICTE, otherwise the Council shall be constrained to stop giving approval obtained partially to only few Technical Course(s)/ Programme(s).
