Subject : Complain regarding the Harassment of SC students.

We are writing this letter to you related to serious issues raised before me by students and parents who are beneficiaries of Post matric Scholarship Schemes implemented by Social Justice and Special Assistance Department, Government of Maharashtra.

Most important schemes which require special mention are centrally sponsored 'Government of India Post Matric Scholarship' and state sponsored 'Tuition fee, Exam Fee reimbursement Freeship scheme'. Under these schemes, annually around 4.5+ lac applications from Schedule caste students are registered throughout the state.

As per guidelines laid down by the Government of Maharashtra from time to time since 2003, the Colleges/ Institutions shall allow the SC students to attend their academic courses once admitted and shall not insist or demand or make any compulsion to pay the fees once he/ she has applied for the scholarship scheme.

We must draw your kind attention that, inspite of the above guidelines and several directions circulated by the office of Commissioner, Social Welfare and our respective Regional and District Asst. Commissioner, Social Welfare, it has been frequently reported by the students and their parents that many colleges/ institutions under your university are offering conditional admissions and demanding the students to pay the fees first and get reimbursement of scholarship later on. Such demand is contrary to the law and guidelines issued by the government. Such illegal demand is creating unrest among the deprived community as the scheme objective itself is getting defeated. Secondly, in the current COVID crisis where most of the families are suffering with acute financial challenges if colleges continue to harass students, chance of occurrence of any untoward incident may not be ruled out for which concerned colleges will be responsible.




occurrence of any untoward incident may not be ruled out for which concerned colleges will be responsible.
