4. SHIVAJI UNIVERSITY POLICY FOR PERSONS WITH DISABILITIES

For Inclusion of PWDs in Higher Education Institutions and to provide the facilities to Persons with Disabilities under UGC Scheme for Persons with Disabilities it was decided to frame the Shivaji University Policy for Persons with Disabilities. Committee is formed for Shivaji University Policy for PWDs where Hon. Vice-Chancellor is Chairperson and subcommittees also formed and meetings concern with held four-times and final draft had prepared and last meeting was held under the chairmanship of Hon. Registrar Prof(Dr) V.S. Nandavadekar. Further it will be put for management council for final approval. The draft of policy is highly appreciated by Higher Education Department, Pune and had also taken the reference of this policy for formation of central policy and formation of policy of other universities. The policy is drafted as follow.

Shivaji University, Kolhapur

Policy for Persons with Disabilities

I. Introduction:

Rights of Persons with Disabilities Act, 2016 prohibits discrimination against individuals with physical and mental disabilities. Shivaji University and its affiliated colleges and its affiliated institutions are against all kinds of discriminations on any grounds including disability. The university and its affiliated colleges and its affiliated institutions aim to promote an inclusive learning, teaching and working environment in which disabled students and Staff are not disadvantaged or treated unfavourably. The university aims to make each of its programs, services, and activities accessible to and usable by all the persons with disabilities. All the stakeholders of Shivaji University, affiliated colleges, recognized institutions and research centers share the responsibility for helping people with disabilities to secure the Benefits of campus programs, services, and activities. These guidelines apply to all University Faculty and staff including those at the academic departments, recognized institutions, research centers and affiliated colleges.

Policy Statement:

II. Objectives of the Policy

- 1. To create Inclusive Culture to avoid discrimination, exploitation and exclusion of Disable Students and Staff from all spheres of work and education
- 2. To create suitable regulatory mechanism for effective delivery of services to Disable Students and Staff of affiliated colleges, recognized institutions and research centers.
- 3. To ensure implementation of all legislations with respect to persons with disabilities.
- 4. To provide accessible and inclusive education at affiliated colleges, recognized institutions and research centers
- 5. To ensure full participation of persons with disabilities and to provide them the equal opportunities for development.
- 6. To provide necessary budget allocation to achieve above objectives. (three percent of total university budget)

II. DEFINITIONS:

The terms used in the policy have meaning mentioned in chapter I of the rights of the persons with disability Act 2016.

A. Disability

Disability is a term that includes motor and sensory limitations (e.g., mobility, vision, or hearing impairments). It also includes disabilities resulting from chronic illnesses and syndrome, invisible disabilities, such as psychological and emotional disorders, learning disabilities, heart disease, diabetes, asthma, arthritis, epilepsy, Acquired Brain Injuries (ABI), and Acquired Immune Deficiency Syndrome (AIDS) are also included in the term disability. Many disabilities vary in degree and type of limitation; therefore, accommodations must also vary and should be tailored to the needs of the individual.

B. Qualified Person with Disability

The term "qualified person with a disability" refers to an individual with a disability who is qualified to participate in any given university program or activity.

1. With respect to enrolment, a qualified person with a disability must satisfy the academic standards required for admission and meet the academic requirements established for any given course, degree, or certificate program.

2. With respect to employment, training, work assignments, and promotion, a qualified individual with a disability must be able to perform the minimum essential functions of the job.

3. However relaxation shall be allowed as per the Government rules.

III. Governing bodies:

Shivaji University and its affiliated colleges and its affiliated institutions will constitute an expert committee for persons with disabilities which will be responsible in formulating, implementing and revising policy and guidelines for persons with disabilities.

The committee shall consist of minimum five members selected from faculty from the university, experts in the field and persons with disabilities. All committee members shall be appointed by Vice Chancellor of the University and Principals and Heads of Recognized Institutions and Research Centers for period of five years. The committee should meet at least twice a year to review the concerned activities.

The major functions of expert committee for persons with disabilities include:

- **A.** To address all disability related issues in the university and affiliated colleges& recognized institutions and research centers
- **B.** To ensure overall accessibility for persons with disabilities in the entire university system including university departments, affiliated colleges, recognized institutions and research centers.
 - **C.** To guide activities of the enabling units or resource centre by providing expert suggestions.
- D. To resolve major grievances pertaining to any matter of persons with disabilities. The mater shall be first referred to HODs, the Principals & Coordinators in the affiliated colleges& recognized institutions, research centres and university campus. If it is not resolved, it should be sent to the competent authorities.

Enabling Units for persons with disabilities:

Shivaji University has established resource centre for inclusive education for persons with disabilities in the university campus. This centre will be renamed as Enabling Unit for persons with disabilities. The enabling unit will be coordinated by a coordinator to be

nominated by Honourable Vice Chancellor. A counsellor-cum-placement officer shall be appointed for the Enabling Unit amongst the faculty members of the university. Considering the various functions and activities of Enabling Unit, required supporting staff shall be provided by university. The affiliated colleges, recognized institutions and research centers will also be directed to establish enabling units for persons with disabilities.

The enabling unit (EU) shall work in the coordination with Expert committee for persons with disabilities (ECPD) for implementation of university policy for persons with disabilities.

The major functions of the resource centre or Enabling Unit will be as follows:

a. To provide counselling to students with disabilities on the types of courses they can study at the higher education institutions.

b. To ensure admission of as many students with disabilities as possible through the open quota and also through the reservation meant for them.

c. To collect orders dealing with fee concessions, examination procedures, reservation policies, etc., pertaining to persons with disabilities as per the government policies from time to time.

d. To assess the educational needs of persons with disabilities enrolled in the higher education institutions to determine the types of assistive devices to be procured.

e. To conduct awareness programs for teachers of the affiliated colleges & institutions about the approaches to teaching, evaluation procedures, etc, which they should adapt in the case of students with disabilities.

f. To provide support to the students with disabilities and assist them in getting appropriate employment when desired by them after their studies.

g. To inculcate skills for entrepreneurship development.

h. To celebrate important days pertaining to disability such as the International day for persons with disabilities, Braille Day and White Cane Day in order to create awareness about the capabilities of persons with disabilities.

i. To motivate alumnae for raising funds for scholarships.

k. To organize Remedial Coaching Classes for persons with disabilities.

IV. Accessibility policy:

Providing access means making all the University services, activities and the benefits thereof, fully available to qualified people with disabilities. The university administration and faculty members should ensure appropriate/reasonable accommodations for each person with a disability, and be willing to resolve access problems.

The following principles of accessibility will be strictly observed:

- A. All UG and PG programs and activities must be accessible.
- **B.** To provide accessible textbooks and study material to all students with disabilities.
- **C.** All the academic course content should be compliant to publishing accessibility standards as Digital Access Information System (DAISY).
- **D.** To ensure the awareness programmes for all the teachers and non teaching staff regarding the issues of accessibility.
- **E.** To ensure that web services are compliant to National and international accessibility standards and regulations such as Web content Accessibility Guidelines WCAG with appropriate version and Government of India Guidelines for Web accessibility (GIGW).

V. Admission policy for persons with disabilities

Total five percent seats in all the university programmes including Ph.D. and M. Phil will be reserved for persons with disabilities. The university will ensure the representation of all the types of disabilities listed in Rights of Persons with Disabilities 2016 and as per government regulations from time to time.

VI. Exam policy:

Shivaji University will make suitable modifications in the curriculum and examination system to meet the specific needs of students with disabilities. Reasonable accommodation will be made to accommodate the needs of all the students with disabilities. The examination section has issued the guidelines and regulations for use of scribe in exams. It will be ensured that all the departments and affiliated colleges follow these regulations. The university will also abide by the guidelines regarding Facilities to persons with disabilities in higher education issued by Government of Maharashtra higher and technical education department, vide government decision number 2016 letter number 302/VS-3 04 03 2017.

5. ACCESSIBILITY AND ACCESS AUDIT FOR PERSONS WITH DISABILITIES

Facilities available for Employee and students

- Ramps, Toilets and Lifts
- Two-Wheeler is provided for teacher and staff on the basis of fifty percent concession.
 Half hour concession in regular working hours is facilitated to teaching and non teaching staff.
- New Website was launched with WCAG-2 Certification which was accessible to the differently-abled persons. www.unishivaji.ac.in
- All facilities are provided time to time as per government rules.
- We have Started converting Distance Education curriculum for under graduate Students in Audible format through DASIY Software
- Our website is accessible for visually impaired students. So curriculum for all the course of the Shivaji University can be used by all the PWDs.

9. Seminars and Workshops on Disability:

1. Provisions of the Rights of Persons with Disabilities Bill – 2016 on 24/03/17: To create the awareness about the bill among stakeholders one day workshop was conducted under UGC Scheme for PWDs by Coordinator Dr.P.B.Desai and Chief Guest Director, Chetan Apangmati Khebudkar had expressed his views and 30 disable students and employees were present for the programmes.

2. Workshop on Library Services: To aware disabled students for library services for Disabilities in present Scenario workshop organized at Dr. Patangrao Kadam College of Sangli in collaboration with Resource Centre for Inclusive Education, Shivaji University Kolhapur on 16/02/2019.

10. Skill and Job Fair for Persons with Disabilities:

In the university history Shivaji University had organized the First Skill and Job Fair for Persons with Disabilities. We got huge response and total 296 disables had registered and more than 150 people got jobs. Shivaji University is playing leading role in recruiting the more number of disables. In collaboration with UGC Scheme for Persons with Disabilities, Resource Centre for Inclusive Education and Centre, Placement Cell & Skill Development this skill and job fair was conducted.

9. Working Scheme and Centres on Disability Working Scheme and Centres On Disability

RESOURCE CENTRE FOR INCLUSIVE EDUCATION:

RCIE was established with the financial support from Rashtriya Uchchatar Shiksha Abhiyan (RUSA), Government of Maharashtra. The center works to empower the persons with disabilities through inclusive higher education.

The centre aims at incorporation of students with significant disabilities into general academic courses in universities and colleges along with non-disabled students.

The centre works for the inclusion and development of visually impaired, hearing disabled, orthopedically impaired and mentally challenged students from affiliated colleges of Shivaji university and its departments, special schools for persons with disabilities.

UGC SCHEME FOR PERSONS WITH DISABILITIES

The Persons with Disabilities Act 1995 indicates that differently-abled persons should have access to education at all levels. In the higher education sector, the University Grants

Commission (UGC) is supporting universities in the country to involve in special education activities to empower differently-abled persons.

The UGC had started the scheme of assistance particularly to universities to facilitate. Initially the UGC had sanctioned the UGC-Scheme for Persons with Disabilities for period 2012-2017 and now university got two yrs extension. Advisory Committee is formed and Honourable Vice-Chancellor is Chairperson.Shivaji University Policy is drafted under this scheme and many orientations and awareness programmes were conducted under this scheme.

The specific objectives of Scheme

- 1. To provide equal educational opportunities to differently-abled persons in higher education institutions.
- 2. To create awareness among the functionaries of higher education about the specific educational needs of differently abled persons.
- 3. To equip higher education institutions with the facilities to provide access to differently-abled persons.
- 4. To provide special devices to higher education institutions that will augment the learning experiences of differently-abled persons.
- 5. To monitor the implementation of all existing and future legislation and policies, which are pertaining to higher education of differently-abled persons.

CENTRE FOR THE STUDY OF SOCIAL EXCLUSION AND INCLUSIVE POLICY

Centre for the Study of Social Exclusion and Inclusive Policy, Shivaji University, Kolhapur is a new multi-disciplinary teaching and research centre established in April, 2007 under Xth plan of the UGC. The Centre has planned to carry out research and teaching in the area of Social Exclusion, Discriminatory Studies and Inclusive Policies. It has further decided to concentrate on conceptualising and contextualising discrimination, social exclusion and inclusion based on caste ethnicity gender and religion. This centre is carrying the research on disability and policy inputs for disability.
