



Rules for Research Institute

Under Faculty of Humanities, Commerce & Management and Interdisciplinary Studies

- 1. The Management of an institution actively engaged in conducting research or specialized studies for a period of not less than five years, and seeking recognition shall apply with full information to the Registrar of the University before the last day of September of the year preceding the year from which the recognition is sought.
- 2. The Institute must be registered with charitable commissioner / under charitable trust / Society Act, under section-8 of Companies Act-2013.
- 3. The Director shall be the Head of the Research Institute.
- 4. The Institute shall have a well-equipped library with minimum 1000 books (Titles) and minimum 5 reputed Journals in the specific discipline.
- 5. There shall be State of Art, ICT (Internet with WIFI connectivity, printer etc.) facility and infrastructure. (Minimum 5 computers required.)
- 6. At least Rs.3.00 lac shall be kept as Fixed Deposit in a Nationalized Bank and should not be withdrawn without the permission of the University.
- 7. The Institute should have at least 2000 Sq.ft. built up area.
- 8. Infrastructure of existing college will not be accepted for research institute.
- 9. Institute shall have last 5 Years annual audit reports.
- 10. There shall be sufficient budgetary provision for the conduct of concerned relevant research activities.
- 11. The Institute shall have One Director and at least One Research Project Officer / Councilor / Surveyor / research assistant in the concerned discipline.
- 12. The institute shall have permanent, visiting and/or honorary staff recognized for guiding research or recognized for the purpose of the institute on the basis of qualification, experience and publications in the concerned discipline.
- 13. Research institute shall have functional MoU with other Institute / College / University / Industrial Units / NGOs / Government Departments etc.
- 14. Institute shall maintain Accession Register/Cashbook, Stock Register and Dead Stock Register etc.
- 15. University will not be responsible for financial liability / irregularities created by the concerned research institute.
- 16. Institute shall organize various activities such as conferences / seminars / workshops / symposium / surveys / training programs / awareness programs / community work etc.
- 17. The research institute shall submit annual report regularly to the university, describing their performance in terms of research outcome, monograph, conferences, seminars and workshop organized etc.
