RULES FOR RECOGNITION OF MULTI-DISCLIPNARY RESEARCH LAB

- 1. A) At least 2 professors/2 Associate professors/ 2 Assistant Professors who are university approved guides working with the college/Institute/Research Institution from any two or more relevant subjects are required.
 - B) One Professor/Associate Professor/Assistant Professor per subject who are recognized research guide of University and with age less than 57 years, working with the College/Institution/Research Institution/College are required
- 2. At least one Post Graduate batch shall have been passed out from each subject (in case of teaching institute/College.
- 3. For each respective discipline a dedicated laboratory of minimum 200 sq.ft. Exclusively with equipment's essential for research is essential
- 4. The College/Institute/Research Institute shall have regular subscription to at least two National and two International journals in the relevant field of Research. Sufficient technical Literature shall be available in the relevant field with back volumes of National/International journals in the Library either in printed or electronic form
- 5. At least Rupees three lakh budgetary provision shall be made in the annual budget and be spent exclusively for the development of Research facilities of the concerned multi-Disciplinary lab.
- 6. There shall be at least ten publications in UGC CARE journals/Scopus/Web of Science Journal/PubMed from the Institute/college in the last five years.
- 7. College/Institute shall have valid certificate of accreditation by NAAC/NBA.
- 8. The Centers/Institute/Labs should comply with all Governmental safety and security standards.
- 9. At least one live MoU with College/Research Institute/Industry.
