

Relaxation in cut-off percentage upto 10% subject ... minimum eligibility (i) (ii)

Increase in intuke capacity upto 5% - course - wise. (iii)

Reservation of at least one seat in merit quota in technical/professional Waiving of domicile requirements. (iv)
