Rules regarding minimum qualifications for recognition as a P.G. Teacher/ M.Phil./ Ph.D. Guide in University Departments and affiliated colleges in the faculty of ARTS & FINE ARTS

The basic qualification as a P.G. teacher is Master's Degree in the relevant subject

1) Post-Graduate Teachers (Guide for Ph.D.)

- a) Three years completed after the declaration of Doctorate Degree in relevant subject.
- b) Publication of two Research Papers after the declaration of Doctorate Degree in the journals enlisted by the concerned faculties.
- c) Confirmed Teacher with at least Five years fulltime Teaching experience at P.G. level or Seven Years part time / Contributory teaching experience at P.G. level in the relevant subject or ten years teaching experience at Degree level in the relevant subject.

OR

- d) A person working in the recognized Research / Professional Organization having required Qualifications And publications as mentioned above Rules 1) – a) and b) with five years Experience

2) Post Graduate Teachers (M.Phil. by Papers/by Research)

- a) Two years completed after the declaration of Ph.D. or M. Phil. Degree in relevant subject
- b) Confirmed teachers with at least five years teaching experience at UG / PG level in the relevant subject.

1) Post-Graduate Teachers (Guide for Ph.D.)

- a) Three years completed after the declaration of Doctorate Degree in relevant subject.
- b) Publication of two Research Papers after the declaration of Doctorate Degree in the journals enlisted by the concerned faculties.
- c) Confirmed Teacher with at least Five years fulltime Teaching experience at P.G. level or Seven Years part time / Contributory teaching experience at P.G. level in the relevant subject or ten years teaching experience at Degree level in the relevant subject.

OR

- c) Confirmed Teacher with at least Five years fulltime Teaching experience at P.G. level or Seven Years part time / Contributory teaching experience at P.G. level in the relevant subject or ten years teaching experience at Degree level in the relevant subject.

OR

1) Post-Graduate Teachers (Guide for Ph.D.)

- a) Three years completed after the declaration of Doctorate Degree in relevant subject.
- b) Publication of two Research Papers after the declaration of Doctorate Degree in the journals enlisted by the concerned faculties.
- c) Confirmed Teacher with at least Five years fulltime Teaching experience at P.G. level or Seven Years part time / Contributory teaching experience at P.G. level in the relevant subject or ten years teaching experience at Degree level in the relevant subject.

OR

- d) A person working in the recognized Research / Professional Organization having required Qualifications And publications as mentioned above Rules 1) – a) and b) with five years experience

1) Post-Graduate Teachers (Guide for Ph.D.)

- a) Three years completed after the declaration of Doctorate Degree in relevant subject.
- b) Publication of two Research Papers after the declaration of Doctorate Degree in the journals enlisted by the concerned faculties.
- c) Confirmed Teacher with at least Five years fulltime Teaching experience at P.G. level or Seven Years part time / Contributory teaching experience at P.G. level in the relevant subject or ten years teaching experience at Degree level in the relevant subject.
OR
- d) A person working in the recognized Research / Professional Organization having required Qualifications And publications as mentioned above Rules 1) – a) and b) with five years experience

2) Post Graduate Teachers (M.Phil. by Papers/by Research)

- a) Two years completed after the declaration of Ph.D. or M. Phil. Degree in relevant subject
- b) Confirmed teachers with at least five years teaching experience at UG / PG level in the relevant subject.

Rules regarding minimum qualifications for recognition as a P.G. Teacher/ M.Phil./ Ph.D. Guide in University Departments and affiliated colleges in the faculty of COMMERCE.

Degree qualifications referred to in the following must be in the subject concerned and of Statutory Indian Universities of Foreign Universities of repute.

Subject comprising the Commerce course are divided into two categories.

- A) Professional Subjects : Accountancy and Auditing, Cost Accounting, Auctorial Science, Business Law, Taxation.
- B) Non-professional Subjects : Other than the above.

1) Post-Graduate Teachers (Guide for Ph.D.)

(Professional and Non-professional)

- a) Three years completed after the declaration Doctorate Degree in the relevant subject.
- b) Publication of two Research Papers after the declaration of Ph.D. Degree in the journals enlisted by the concerned faculties.
- c) Confirm teachers at least Five years fulltime teaching experience at P.G. level or Seven years part time / Contributory teaching experience at P.G. level or ten years teaching experience at Degree level in the relevant subject.
- OR
- d) A person working in the recognized Research / Professional / Organization having required qualifications and publications as mentioned above Rules 1) – a) and b) with five years experience

2) Post Graduate Teachers (M. Phil. by Papers / by Research)

(i) NON-PROFESSIONAL SUBJECTS

- a) Two years completed after the declaration of Ph.D. or M. Phil. Degree in relevant subject.
- b) Confirmed teachers with at least five years teaching experience at UG/PG level.
- c) Publication of two Research Papers after the declaration of Ph.D. Degree in the journals enlisted by the concerned faculties.

(ii) PROFESSIONAL SUBJECTS

- a) C.A./I.C.W.A./C.S. in the relevant subject with Ph.D. or M.Phil.
- b) Confirmed teachers with at least three years experience at UG/PG level.
- c) Publication of two Research Papers after the declaration of Ph.D. Degree in the journals enlisted by the concerned faculties.

3) Post Graduate Teachers (for Master's Degree)

(NON-PROFESSIONAL/PROFESSIONAL SUBJECTS)

- a) Full time approved teacher in senior college with Ph.D. or M.Phil. Degree
- OR
- b) At least five years teaching experience at U.G. level.

Note:

- 1) If Master Degree B+ with C.A. is not available, C.A. with five years degree teaching experience may be considered for recognition.

Rules regarding minimum qualifications for recognition as a P.G. Teacher / Ph.D. Guide in University Departments and affiliated colleges in the faculty of **ENGINEERING and TECHNOLOGY**

1) Post –graduate Teachers (Guide for Ph.D.)

- a) One year completed after the declaration of Doctorate Degree in the relevant subject.
- b) Publication of two Research Papers after the declaration of Ph.D. Degree in the journals enlisted by the concerned faculties.
- c) Three years full time experience of teaching post-graduate classes or ten years full time teaching experience at U.G. level in the relevant subject
OR
- d) A person working in the recognized Research/ Professional /Organization having required qualifications and publications as mentioned above Rule 1)-a) and b) with five years experience in reputed Firm Company

2) Post-graduate Teachers for M.E

- a) Ph.D. or M.E. or M.Tech. in relevant subject.
- b) Three years full time experience of teaching for final year B.E. Classes
Or
- c) A person working in the recognized Research / Professional / Organization having required qualifications and five years research / industrial experience.

3) Post-graduate Teacher (By Research)

- a) A Master Degree in relevant Subject / Branch.
- b) Total ten years of teaching / industrial experience out of which five years should be at final year B.E. class./ Ten Years Industrial Experience.
- c) At least one research papers published in journal enlisted by concerned faculties

Rules regarding minimum qualifications for recognition as a P.G. Teacher / Ph.D. Guide in University Departments and affiliated colleges in the subject of **PHARMACY** faculty Engineering & Technology.

1) Ph.D. Guide

- a) One year completed after declaration of Ph.D. degree in the appropriate branch of specialization of University or a recognized institute as approved by AICTE & Pharmacy Council of India and should have not less than 10 years teaching experience.& research experience after obtaining his M.Pharm. qualification & out of which 5 years teaching experience at M.Pharm.
- b) Publication of two Research Papers after the declaration of Ph.D. Degree in the journals enlisted by the concerned faculties.

2) Post Graduate Teachers

- a) Post-graduate degree of University or recognized institution as approved by AICTE & Pharmacy Council of India.
- b) Three years full time teaching experience as a Assistant Prof. /Associate Prof./Professor at degree Pharmacy college.

Rules regarding minimum qualifications for recognition as a P.G. Teacher / Ph.D. Guide in University Departments and affiliated colleges in the subject of **ARCHITECTURE** faculty Engineering & Technology.

(As per council of Architecture, New Delhi, Guidelines-2006)

(Degree qualifications referred in the following must be in the subjects concerned and of Statutory Indian Universities or Foreign Universities of repute.)

1) Post-Graduate Teachers (Guide for Ph.D.)

- a) A Doctorate Degree.
- b) A Master's degree with Independent published Research Work at least two papers in journals enlisted by the concerned faculty.
Or
- c) Completed two Architectural Research Projects.
- d) Three years experience of teaching for post graduate classes.

For Architecture Engineering From Profession / Industry:-

If a candidate is not possessing Post-Graduate Or Ph.D. degree but has at least 20 years' Professional experience with outstanding performance and contribution to the field of Research evidence by research publications can be considered as a research guide for Ph. D.

2) Post-Graduate Teachers for M. Arch.

- a) Ph. D. or M. Arch. in relevant subject.
And
- b) Three years teaching experience at final year B. Arch. Classes.

Rules other than minimum qualifications :

- a) Those who are appointed conditionally (such as passing of NET/SET) shall be recognized conditionally for three years, subject to the fulfillment of the conditions mentioned above.
- b) Those exempted from NET/SET may be considered for permanent recognition, subject to fulfillment of the conditions mentioned above.
- c) Those selected as Assistant Professor in University Departments under section 76 of the Maharashtra Universities Act 1994 or Selected as Assistant Professor for Post Graduate classes in affiliated colleges shall automatically stand as a recognized P.G. teacher.
- d) A Assistant Professor appointed in the University Department under Section – 76 of the Maharashtra Universities Act 1994 automatically stands recognized as post-graduate teacher for M.Phil. by papers and dissertation and M.Sc. (Theory and dissertation) provided he / she is a Ph.D. holder.
- e) Those selected as Professor/Associate Professor or designated Reader in the subject in the University department under section 76 of the Maharashtra Universities Act 1994 shall automatically be recognized as Post-graduate Teacher for Master's Degree, M.Phil. and Ph.D.
- f) Those who are selected on Local appointment basis may be allowed temporary recognition for post-graduate teaching subject to five years degree teaching experience.
- g) Those who are recognized for P.G. teaching shall not be allowed to work at more than one college and not allowed to teach more than one paper.
 - a) In case a UG teacher wants to teach more than one paper at PG level, he will not claim for remission of teaching for more than one paper.
- h) The temporary teachers having major projects in the relevant subject shall be permitted to guide M. Phil. / Ph.D. students after due approval of Vice-Chancellor. However they shall have to take co-guide from the permanent faculty
- i) For interdisciplinary subjects teachers from any subjects having experience of teaching / research in the relevant subject / topic may be permitted to be a co-guide from the permanent faculty.
- j) A recognized Post-Graduate teacher of any recognized University who is already retired may be allowed to work in the honorary capacity to teach or guide Post-Graduate students up to the age of 65 years. The guide has to complete Four terms before the age of 65 years i.e. superannuation. Student should allowed to guide up to the age of 63 years
- k) Recognition will be granted till he / she is working in the jurisdiction of University or in the recognized Institute.
- l) Outside person working in the recognized Research / Professional/ Organization having Required qualifications and publications as mentioned above rules 1)- a and b, can be approved as Ph.D. Guide as a special case on the recommendation of the Dean's of the respective faculties subject to the approval of Hon. Vice Chancellor.
- m) Regular Teacher in the University Department and Government College Should provide Experience Certificate from Principal / Director / Department instead of University Approval.
- n) In case of the inadequate number of guides in any subject in the University Jurisdiction other teacher may be considered for M.E./M.Tech./ M.Phil. / Ph.D. guideship recognition as a special case.
