UGC has decided to operate the scheme from the respective Regional Offices..

The interested Colleges seeking financial assistance under this scheme may submit their proposal complete in all respect in the prescribed proforma as per XII Plan guidelines through Director (BCUD) of affiliating University to UGC-WRO, Pune **on or before 8th September 2014**. The colleges should also attach "Certified copies of title deeds of the land on which the construction is proposed to be constructed" OR " Certificate regarding area and complete address on which the construction is proposed to be undertaken" while submitting the above proposal

It may also be noted that the self-financing colleges though they are recognized under section 2(f) and 12(B) of UGC Act, 1956 are not eligible for financial assistance under this scheme.
