#### 1. PREAMBLE:

The discipline of Defence Studies encompasses a broad range of subjects, combining military science, strategy, international relations, security policies, and technological advancements in the defence sector. This syllabus is designed to provide students with an in-depth understanding of the various dimensions of defence, both in theory and practice, equipping them with the necessary knowledge and skills to engage with contemporary defence issues effectively.

#### 2. PROGRAMME LEARNING OUTCOMES (PO)

- Demonstrate knowledge of the structure, functioning, and role of international and regional organizations (e.g., the United Nations, NATO, SAARC, ASEAN) in maintaining global and regional security.
- Evaluate the evolving nature of India's national security in the context of regional and global security challenges.
- Develop an understanding of key geopolitical concepts and theories, and their application to global security and military strategy.
- Examine the nature and evolution of warfare, including the shift from traditional to contemporary warfare.
- Understand the key theories, concepts, and principles of international relations (e.g., realism, liberalism, constructivism) and their relevance to global security issues.
- Analyze the role of the Maratha Empire in shaping the military and political landscape of India during the 17th and 18th centuries.
- Understand the evolution of India's military history, from ancient warfare to the post-independence period.

#### 3. **DURATION:**

The Bachelor of Arts in **DEFENCE STUDIES** (**ENTIRE**) programme shall be A FULL TIME COURSE OF 3/4 YEARS – 6/8 SEMESTERS DURATION with 22 Credits per Semester. (Total Credits = 132/176)

#### 4. ELIGIBILITY FOR ADMISSION:

The candidate who has qualified SENIOR SECONDARY SCHOOL EXAMINATION (10 + 2) OR

EQUIVALENT from a recognized board/institute is eligible for admission for this course. The criteria for admission is as per the rules and regulations set from time to time by concerned departments, HEIs, university, government and other relevant statutory authorities.

#### 5. MEDIUM OF INSTRUCTION:

The medium of instruction shall be ENGLISH or MARATHI. The students will have AN OPTION TO WRITE ANSWER-SCRIPTS IN ENGLISH OR MARATHI. (EXCEPT LANGUAGES)
