(35) Acceptance of Indira Gandhi National Open University (IGNOU), New Delhi's different distance programme's curriculum.

Submission:

(Under the chairmanship of Hon'ble Vice Chancellor of University, a committee was established for opening Indira Gandhi National Open University (IGNOU), New Delhi's, Distance Education Council's (DEC) Centre. As per academic councils resolution no.4 dated 30th August, 2005 proposal was submitted to DEC, New Delhi. As per this proposal and under 10th five year plan during the economic year 2005-06 ten lakhs development fund was sanctioned and it will be released in two installments. As per this, a request letter was sent to the DEC for the first installment on 31st October, 2005.

For approving above development fund following conditions are kept by DEC.

- i) Submission of undertaking for mutual recognition of programmes.
- ii) Submission of Utilization Certificate and refund of unspent balance of the previous financial year grant sanctioned by Distance Education Council.
- iii) Submission of application for approval of programme(s) in the prescribed Distance Education proforma.
- iv) Undertaking to offer programmes within the jurisdiction and with prior approval of DEC.

from above item no. 1 & 2 are fulfilled and 3 & 4 related action have to be taken. Therefore DEC curriculum should be adopted. Hence B.A., B.Com., and M.A., M.Com. exams study material is required from the IGNOU. Hon'ble Vice Chancellor has appointed a committee comprising Board of Studie's, Chairpersons and Head of Post Graduate Departments to submit the report regarding equivalence of IGNOU programmes and our university programmes. As per report if there is 80% equivalence of the programmes then it will be accepted and these reports are kept in front of University Authority Board. As per Academic Council 23rd November, 2005's meeting the resolution regarding principally acceptance of 80% equivalence of curriculum is as follows:

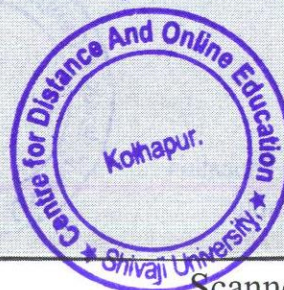

Therefore, the said resolutions point No. 1, 3, 4, 6 & 7 for information and 2 & 5 are submitted for the decision.)

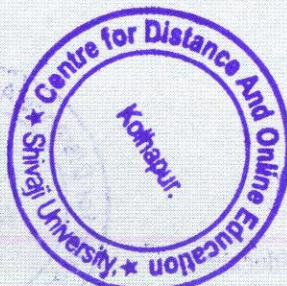
