If your performance is not found satisfactory during your service period or your services are not required to the University, your service will be terminated after the notice period of one month.

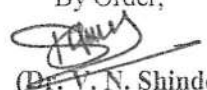
You will not be entitled to claim the privileges, benefits that are available to regular employees of the University.

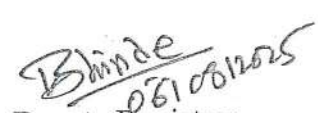
