And

Whereas the report of the UGC Committee on the Examination and Academic Calendar for the Universities in view of Covid-19 pandemic and lockdown situation is accepted by the University Grants Commission and sent to all Universities for execution vide its letter dated F-1 (2020) dated 29th April 2020, and in continuation revised guidelines are issued dated 6th July 2020 for conduct of examination of final year students.

And

Whereas Hon'ble Supreme Court in its judgment dated 28/06/2020 in WP (Civil) No. 724 of 2020 and others gave approval to the UGC guidelines dated 6th July 2020 and directed to conduct the examination of final year/terminal/ Semester examinations, it is necessary to conduct the examination of final year final semester students.

And

Whereas as per the guidelines of the UGC notified from time to time, and order of Hon'ble Supreme Court dated. 28th August 2020, Government of Maharashtra through Director, Higher Education vide its letter No. युएन आय/2020/ बैठक/विशि –1/5640–A dtd. 3rd September 2020, directed all the universities to conduct the examinations of all final year final Semester Students.

And

Whereas the Authorities of Shivaji University Kolhapur have also accepted the said notification of UGC and directives of State Government, which are issued in accordance with Supreme Court decision.

And

Whereas in these circumstances ordinances relating to conduct of examination, evaluation and declaration of the results and rules and regulations approved for the course examination by the University cannot be made applicable.

And

Whereas the matter, therefore is required to be regulated by the ordinances, rules, regulations and in the absence of the same and considering the exigency of the matter for time being issuance of the directions by the Vice-Chancellor under Section 12(8) of Maharashtra Public Universities Act, 2016 is necessary.

Therefore, I Prof. (Dr) Digambar Tukaram Shirke, Vice-Chacellor, Shivaji University, Kolhapur hereby regulate the matter by issuing following directions in exercise of powers conferred upon me under Section 12(8) of Maharashtra Public Universities Act, 2016 in respect of conduct of examination and declaration of results of the final year, final semester examinees due to appear at Summer Session 2020 examination.

The examination of final year final semester students will be conducted through online/offline mode. The examination will be of 50 marks per paper (per head of passing for written examination) and of one hour duration with multiple choice questions (MCQ). It is also applicable to repeater students who have submitted their candidature for the summer 2020 examination. This examination will be conducted by the respective Colleges/Institutions/ University Departments.

The marks obtained out of 50 in the examination conducted as per the above procedure will be converted suitably by considering the maximum number of marks for that head of passing. The marks obtained by the examinee in practical/project/dissertation/oral/viva examination conducted as per the decision of Academic Council will be considered. Based on this performance result of the examinee will be prepared.

The provision of photo copy/ revaluation/verification will not be available for this examination.

This order is applicable for the examination of Summer Session of 2020 only.
