The time period for the examination is only 1 hour. Therefore, it is very essential for the students to submit their test in time. The Exam MCQs Question Papers will be issued exactly 5 minutes before the time of the paper to allow you to fill in the information. All the other rules and ordinances will be followed as per the University norms. Students are required to join the video App (Zoom or Google Meet as the case may be) at least 10 minutes before the exam starts to listen to the oral instructions that may be given by the Senior Supervisor.
