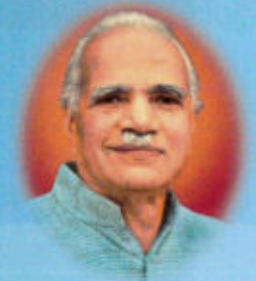

About the Indian Institute of Education:

The Indian Institute of Education, Pune is a nationally and internationally renowned institute founded by the legendary educationist Padmabhushan Prof. J. P. Naik (1907-1981) - humanist, freedom fighter, polymath, encyclopaedic thinker, educationist and socialist. He was recognized by the UNESCO alongside Rabindranath Tagore and Mahatma Gandhi as three pioneering educationists of the 20th century. Prof. J. P. Naik is also known as an institution maker. After he passed away the mission of the Indian Institute of Education was carried forward by his spouse Padmashri Dr. Chitra Naik (1918-2010). She continued to contribute to his educational ideologies as well as to the systemic foundations of successive education policies in India.

Dr. Chitra Naik contributed her rich experience in education and social development in the Planning Commission, State Planning Board, National Literacy Mission and Directorate of Education as well as Directorate of Higher Education and also as Chairperson of IIE. She held various positions like Member of Planning Commission, GoI., Consultant in School mapping and micro-planning of Education, Asian Institute of Educational Planning and Administration, Director of National Institute of Basic Education, Chairperson of Non-Formal Education Committee of HRD, and Member of National Literacy Mission. She received the prestigious Jannalal Bajaj Award, first Jan Amos Comenius International Award UNESCO-Paris and Raja Roy Singh Award for outstanding contribution to "Education for All" in the Asia and Pacific Region.

The Indian Institute of education caring the Studies in Inclusive education, health, minorities and tribes and these are the leitmotifs of teaching, research and pedagogy of the institute. The institution is presently working on interdisciplinary approaches in education and social sciences through its centers.

Concept Note:

The legendary Prof. J. P. Naik and Dr. Chitra Naik, eminent educationists who laid the foundation of education not just for India but among many developing countries through official interventions such as the Kothari Commission (1966) and the Karachi Plan for primary education in Asia. They followed the Gandhian ideology of education and life through theory and practice. Prof. Naik manifested the interdisciplinary approach in education and indigenous lifestyle in Mauni Vidyapeeth, Gargoti, Dist-Kolhapur. Prof. Naik realised the significance of holistic learning along with dignity of labour, leading to sustainable learning objectives. He proposed a triangle of quality, quantity and equity for universalisation of education with social justice. He laid the foundation of all prominent higher education institutions in India along with an educational philosophy that forms the bedrock for new education policy to launch in the nation into the 21st century.

The National Education Policy (NEP) 2020 offers an opportunity to break the barriers of prevailing traditional and colonial education system by enabling flexible and experiential learning leading to development of higher order thinking skills via a multidisciplinary and holistic approach. It especially seeks to address quality and equity in education by a complete restructuring of the education system, inter-alliances of disciplines, significant rise in the expenditure on education and also seeks to enhance social inclusion and gender parity. Its vision of 'Vasudhaiva Kutumbakam' via intercultural sharing through internationalization of education is a push towards positioning India globally. At the same time, since the NEP-2020 is a huge shakeup of the education system the challenges for its successful implementation are manifold. A shift from 10+2+3 to 5+3+3+4 pattern poses an implementation challenge. An exaggerated dependence on rote learning is being sought to be replaced by a critical and practical approach through vocational learning and a theoretical base. This will be a huge responsibility towards the teachers and their training. The multidisciplinary approach in higher education shall be a long haul to develop since compartmentalization of higher education on the lines of rigid disciplines has been the core of our educational system. The hierarchy of disciplines adhered to by individuals and institutions shall be the biggest hurdle in training and implementation of the NEP-2020. The proposed regulatory, evaluative and accrediting structures shall call for new training, technological felicity and new mindset for all stakeholders. The proposition of autonomy to higher education institutions brings in responsibility of academics, accounting, evaluation and certification on individual colleges and universities with the onus of mobilizing their own resources. The school and college clusters call for alignment of neighbourhood schools and colleges for sharing of manpower and infrastructure. This calls for giving up identity in the larger interests of upgraded facilitation and shared knowledge. The proposition of cooperation between public and private educational entities and education-industry collaboration challenges the ideological moorings of the society.

The NEP 2020 insists that education must develop cognitive capacities like critical thinking and problem-solving attitude and also social, ethical and emotional capacities and dispositions with insight learning capacities. The challenge to perceive knowledge for personal and community benefits in the framework of social, emotional and ethical standards is a huge diversion from the earlier individualized and cut-throat competition-based learning process. All these call for a change in approach, upskilling and resource diversification in the education system. All educational institutions have to implement the NEP-2020 during the coming years and are bound to take varied responsibilities for implementation issues and challenges. This national conference takes up this issue to provide a platform for sharing of the NEP-2020 implementation issues, responsibilities, experiences, strategies and solutions among various schools and higher education institutions for a smooth and effective implementation of the NEP 2020.

Objectives of the Conference:

2. To make aware roles and responsibilities to stakeholders in higher education under NEP-2020
3. To explore innovative ideas and experiences in higher education with appropriate solutions to implement the NEP

The authors are invited to submit original, unpublished (not simultaneously submitted to another journal or conference) Research papers, Case Studies, Best Practices and Implementation Strategies on the main theme or related sub-themes. Please note that there are no charges for editing, printing or publication of the papers. The papers shall be published on First-Come-First-Serve basis.

The Research paper shall be subjected to quality review and publication by a team of editors. The presented papers shall be published in 'Shikshan Ani Samaj' (Education and Society), UGC-Care Listed Journal (ISSN: 2278-6864).

Note: Attendance in the conference is essential to be considered for paper publication.

Guidelines for Paper Submission:

1. Word Limit for the paper:

Abstract: 300 words

Research Paper: 2000 words

2. No. of Authors: Not more than three

3. Font Size **a. For English:** Times New Roman; Font Size: 12; Line Spacing: 1.5

b. For Devnagari (Marathi/Hindi) Google UNICODE; Font Size: 12; Line Spacing: 1.5

4. An empirical paper should include Abstract, Keywords, Introduction, Methodology, Result Description, Conclusion, Tables, Figures, and References. Theoretical and conceptual papers are also acceptable.

5. **Author details:** Full name, Designation, Affiliating institute, Phone number, and emailID should be mentioned only on the first page of the manuscript.

6. Tables and charts should have self-explanatory titles and be numbered as referred to in the text. The sources, wherever necessary, should be mentioned at the bottom of the tables/charts/graphs.

7. Use APA 7th Edition for in-text citation and referencing.

8. Plagiarism in any form is not accepted and if found, the paper shall be rejected and its presentation not allowed in the conference.
