Concept Note

The term "Amrut Kaal" has its roots in Vedic astrology and is commonly understood as the auspicious or proper moment to begin any action or task. In the context of the social inclusion of tribes in India, the central government has framed this period as an Amrut Kaal, emphasizing it as the right time to discuss the issues and challenges faced by tribal people and work towards their social inclusion.

After independence, various initiatives have been taken to improve the socioeconomic conditions of tribal people and uphold the constitutional protections granted to them. The Central and State Governments have formulated different programs and policies to promote the welfare and development of tribal people, in subsequent five-year plans to bring them at par with mainstream. However, the implementation of programs and polices has not always positive consequences, as some indigenous communities have found themselves in a state of exclusion.

Despite the expectation that tribal peoples should have been at the top of the development scale in terms of inclusive policies implemented after independence, the reality is that tribal people are becoming marginalized, having their land taken from them, becoming poorer, and feeling excluded. The development process, which continuously uproots and marginalizes tribal people, is the most significant cause of these consequences



To address this issue, leading academics, scientists, researchers, and research scholars are invited to gather for a conference to share experiences and research findings on all facets of Amrut Kaal and tribal inclusion in India. The conference aims to provide scholars, practitioners, and educators with a premier interdisciplinary forum to share and discuss the most recent advancements, concerns, and trends as well as real-world difficulties faced and probable solutions in the areas of tribal exclusion and inclusion.

Objectives of the Conference

- 1. To facilitate interdisciplinary dialogue among academics from diverse social science disciplines to understand the challenges being faced by tribal communities during Amrut Kaal.
- 2. To discuss various forms of social exclusion and inclusive policies for indigenous communities.
- 3. To evaluate critically and intervene the inclusive tribal policies in Amrut Kaal
