



The main objective of the scheme is to strengthen the roots of democracy, inculcate healthy habits of discipline, tolerance of views of others & to spread awareness about Parliamentary functions and procedures amongst the Student Community.

2. This Ministry has initiated the process to conduct the 15<sup>th</sup> National Youth Parliament Competition, 2018-19 in association with 45 Universities / Colleges of the Country. In this direction, this Ministry has divided 45 Universities/ Colleges, who are participating in 15<sup>th</sup> National Youth Parliament Competition 2017-18, into 07 (Seven) Groups and each Group has been placed under a Group Coordinator, who has been appointed by this Ministry from amongst the participating institutions. A list showing the names of the Universities/ Colleges placed under 7 Groups & the Group Coordinators is enclosed for ready reference.

3. The competition will be held in two stages —the first stage at the group level for which the participating institutions have been divided into groups as mentioned above and second stage at National level between the winners of the various groups. All Universities/ Colleges may kindly note that the last date to complete the Group Level Competition is 30 November 2018 and in no case the request to extend the last date will be entertained from any institution.

4. The Group Coordinator will be responsible to coordinate and conduct the Group Level Competition in respect of each institution allotted to him and submit a report thereon to this Ministry. The group level competitions for each institution will be evaluated by a team consisting of (i) an Member of Parliament/ Ex-Member of Parliament; (ii) An academician of repute from non-participating educational institution; and (iii) Group Coordinator. All Group Coordinators may kindly ensure that the Group Level Competition in respect of Universities/Colleges allotted to them is held within the stipulated time & a consolidated report containing the (i) list of 6 Prize Winning Students from each University/ College & (ii) Evaluation Sheets duly signed by the 3 Evaluators, is submitted to the Ministry latest by **December 10<sup>th</sup>**, **2018**. This Ministry would re-imburse all expenses incurred on account of TA/DA as per their entitlement or cheapest air-fare in the economy class (shortest route) whichever is lower for the expenses incurred in connection with journeys undertaken by the Group Coordinators duly countersigned by Registrar of University/ Educational institutions. It is also intimated that rules regarding travel by private airlines would be applicable for journeys performed by Group Coordinators for discharging their duties as evaluators in the Group level Competitions. (Copy of Guidelines has already been provided vide this Ministry D. O letter 5(4)/2017-YP dated : 14<sup>th</sup> March, 2018).

5. The Ministry would also reimburse expenses incurred by each Institution for organizing the Group Level Competitions up to Rs. 25,000/-.

6. Accordingly, all Universities / Colleges are requested to take timely action to conduct the Group Level Competition in coordination with the Group Coordinator so as to avoid the last minute rush.

7. It is also intimated that failure to complete the Competition in time or noncompliance of directions issued by the Ministry may result in debarment of Institutions from future participation in the Competition.
