1. The Post mentioned above is created from University Fund and is not covered under Grant-in-Aid scheme of State Government of Maharashtra.
2. The Tenure of the said post is for five years or till the age of superannuation whichever is earlier.
3. The age of superannuation for the post of Director shall be as per the norm of

4. The existing provisions about reemployment will be applicable as per the State Govt. of Maharashtra G. R. संकीर्ण-२७१५/प्र.क्र.100/13 dated 17.12.2016 and its corrigendum dated 21.02.2018.
5. The candidate may be considered for re-appointment (if performance found satisfactory) for one more term through proper selection procedure.
