A. Eligibility:

- 1. M.B.A., Ph.D. / M.Com., Ph.D. or M.A. (Economics), Ph.D. with specialization in Banking & Finance.
- 2. An eminent scholar with published research work of high quality actively engaged in research with at least ten years experience in Post graduate teaching and/or experience in research at the University / National Level Institutions, including experience of guiding research at doctoral level, preferably in Management Science.

OR

An outstanding scholar with established reputation, who has made significant contribution to knowledge. In exceptional cases, the teachers with 15 years of UG teaching and with research publications in reputed journals in Banking & Finance to their credit could also be considered.

B. Area of Specialization:

The person selected will be expected to lay major emphasis on Research in Banking and Financial Management and also will have to contribute to teaching work in the Department of Commerce and Management.

C. Emoluments:

- 1. A fixed pay of Rs. 40,000/- per month. (Consolidated)
- 2. Residential accommodation will be provided on the University Campus.

D. Nature of appointment:

The total tenure of the post is three years. The initial tenure of the incumbent of the chair professor is one year. Subsequently it may extended for two more years depending on academic performance.
