- 1. The Post mentioned above is created from University Fund and is not covered under Grant-in-Aid scheme of State Government of Maharashtra.
- 2. The Tenure of the said post is for five years or till the age of superannuation whichever is earlier.
- 3. The age of superannuation for the post of Director shall be as per the norm of AICTE and State Govt. of Maharashtra G. R. सावेआ-११११/प्र.क.४४/१९/तां.शि.२ dated. 11/09/2019.

- 4. The existing provisions about reemployment will be applicable as per the State Govt. of Maharashtra G. R. संकीर्ण-२७१५/प्र.क्र.100/13 dated 17.12.2016 and its corrigendum dated 21.02.2018.
- 5. The candidate may be considered for re-appointment (if performance found satisfactory) for one more term through proper selection procedure.

QUALIFICATION: For the post of Director, M.B.A. Unit is as mentioned below.

- a. Ph. D. degree and First Class or equivalent at either Bachelor's or Master's level in the relevant branch.
- b. At least two successful Ph.D. guided as supervisor/ Co-Supervisor and minimum 8 research publications in SCI journals / UGC / AICTE approved list of journals.
- c. Minimum 15 years of experience in teaching / research/ industry, out of which at least 3 years shall be at the post equivalent to that of Professor.
