### TERMS, CONDITIONS and INSTRUCTIONS:

1. The Post mentioned above is created from University Fund and is not covered under Grant-in-Aid scheme of State Government of Maharashtra.
2. The Tenure of the said post is for five years or till the age of superannuation whichever is earlier.
3. The age of superannuation for the post of Director shall be as per the norm of AICTE and State Govt. of Maharashtra G. R. सावेआ-११११/प्र.क्र.४४/१९/तां.शि.२, dated 11/09/2019.

4. The existing provisions about reemployment will be applicable as per the State Govt. of Maharashtra G. R. संकीर्ण-२७१५/प्र.क्र.100/13 dated 17.12.2016 and its corrigendum dated 21.02.2018.
5. The candidate may be considered for re-appointment (if performance found satisfactory) for one more term through proper selection procedure.
6. All decisions regarding this appointment and other facilities will be subject to the approval of University Authorities.
7. Employed candidate shall submit his / her application through proper channel, failing which the application shall be treated as invalid.

The candidate shall submit declaration in prescribed Form – “A” along with the application form as per rule 4 of having small family as per the directives issued by the Government of Maharashtra (Notification dated 28<sup>th</sup> March, 2005). **QUALIFICATION: For the post of Director, is as mentioned below.**

- a. Ph. D. degree and First Class or equivalent at either Bachelor's or Master's level Mechanical Engineering / Civil Engineering / Computer Science and Technology / Electronics and Telecommunication Engineering / Electronics Technology / Chemical Engineering / Food Technology / Environmental Science and Technology / Energy Technology.
- b. At least two successful Ph.D. guided as supervisor/ Co-Supervisor and minimum 8 research publications in SCI journals / UGC / AICTE approved list of journals.
- c. Minimum 15 years of experience in teaching / research/ industry, out of which at least 3 years shall be at the post equivalent to that of Professor.

**Note:**

1. This position shall be of contractual in nature for 5 years and can be extended for one more term depending upon the performance.
2. Performance assessment shall be carried out through a committee appointed by the University Authority.
3. After completing the final term, the incumbent shall join back his / her parent organization in the previous designation from where he / she has proceeded with the designation as Professor / Senior Professor as the case may be.
