The Academic score as specified in Appendix II (Table 3A) for the posts of Assistant Professor in Universities, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance of interview as per Government Resolution ref. no. Misc-2018/C.R.56/18/UNI-1, dated 8<sup>th</sup> March, 2019.
4. Candidates belonging to reserved category outside the State of Maharashtra will be treated as OPEN as per G.R. No.CBC-1084/54577/(1813)/BCW-5, dtd.1/11/1985 & Govt. Circular No. CBC- 1688/(2829)/MAVAK-5, dtd.29/7/1988.

5. Candidates belonging from Reserved Categories shall produce the Caste Validity Certificate as per the directives issued by the State Government vide Circular No. BCC-2011/ प्र.क्र.1064/2011/16-ब, dated 12/12/2011.
6. As per the directives issued by the State Government of Maharashtra. the candidates must submit declaration of having small family in prescribed Form – A, along with the application form. **Form – A is available with the application form.**

**The pay scale for the post of Assistant Professor will be as per the norms of UGC & State Government of Maharashtra in the Academic Level- 10 (Pay Matrix Rs. 57,700- 1,82,400)**

**QUALIFICATIONS:**

- **Following qualifications for the Post of Assistant Professor (Post Code No.18/24–01 to 18/24-03) as per the State Government of Maharashtra, Government Resolution No. Misc-2018/C.R.56/18/UNI-1, dated 8<sup>th</sup> March, 2019 and UGC Notification dated 11.10.2021.**
- A. 1) A Master’s degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
  - 2) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET :

Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws /

Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/ SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in regular mode only;
- b) The Ph.D. thesis has been evaluated by at least two examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars, sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

Note: 1) The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.

2) NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

**B.** The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- (i) Quacquarelli Symonds (QS) ;
- (ii) the Times Higher Education (THE) or
- (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).
