- **Post – Assistant Professor (Post Code No. 12/19 – 01 to Post Code No. 12/19 – 28) B.E. / B. Tech. and M. E. / M. Tech. in relevant branch with First Class or equivalent either in B. E./ B. Tech. or M.E. / M. Tech.**
- **Post – Assistant Professor (Post Code No. 12/19- 29 and Post Code No. 12/19- 30)**
 - i. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in seven point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
 - ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
 - iii. Notwithstanding anything contained in sub-clauses (i) and (ii) of UGC Notification's (Dated 30/6/2010) Clause 4.4.1, candidates, who are, or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.
 - iv. NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.
