Election of the President and Secretary of the University Students' Council from amongst its Student members as per Statute S. 453 and S. 454 framed under the provisions of Maharashtra Public Universities Act 2016, 99, 147 (2) (b); Maharashtra Ordinance No. XXVIII of 2017 dated 28/11/2017

It is hereby notified for information of all the student members of the University Students' Council that the election of the President and the Secretary of the University Students' Council from amongst themselves will be held in the first meeting of the University Students' Council convened by the Vice-Chancellor on **Tuesday 27 February, 2018** at 2.30 p.m in the Management Council Hall, Shivaji University, Vidyanagar, Kolhapur-416 004.

In accordance with Statute S. 413 and S. 414 nominations are invited so as to reach the undersigned not later than 4.00 p.m. on **Saturday 17 February, 2018**. Nominations shall be in the prescribed form and shall be dated and signed by any two electors and shall contain the names and full addresses and designations, if any, of the signatories i.e. the Proposer and Seconder and of the candidate nominated. No person shall be nominated as a candidate for election unless he/she signifies his/her consent under his/her signature and date of the nomination paper. No person shall either propose or second his/her own nomination. A nomination paper which does not comply with all the requirements laid down by the Statute in this respect shall be rejected.

The scrutiny of the nominations in connection with the election will be carried out by undersigned or his nominee as per Statute S. 416 on **Saturday 17 February, 2018** at 4.30 p.m. Candidates or their agents duly authorized by them in writing on their behalf will be entitled to be present at such scrutiny to be held in the University Office.

In accordance with the Statute S. 415 it shall be open to the candidate to withdraw his/her candidature from the election provided he/she sends an intimation of withdrawal in writing signed by the candidate and duly attested by a Magistrate OR Principal of affiliated colleges and Head of the university departments/ Recognised Institutions to the undersigned so as to reach him before 4.00 p.m. on **Tuesday 20 February, 2018**. A list of the candidates validly nominated for the election will be sent to each elector soon after the last date of withdrawal is over. If the election is contested the same will be held at a meeting to be held on **Tuesday 27 February, 2018** and the voting papers will be issued on to the members present at the meeting on **Tuesday 27 February, 2018** between 2.45 p.m. and 3.15 p.m., member(s) coming after the specified time will not be entitled to get the voting paper(s).




