NOTICE OF ELECTION

Election of the two members of the Academic Council **on the Management Council**, as per the section 30(4)(j) of MPUA 2016

In exercise of the powers conferred upon me under Sub-section 6 (d) of Section 14 of the Maharashtra Public Universities Act, 2016 and as provided in Election Statute under official Gazette of Government of Maharashtra dated 29th April, 2017, it is hereby notified for the information to all the Members of Academic Council that the election of two members of Academic Council to the **Management Council** under sub section 4(j) of section 30 of the Maharashtra Public Universities Act, 2016 shall be held by ballot at the meeting of the Academic Council on **Saturday, dtd. 2nd September, 2023 at 12.00 noon at Rajarshi Shahu Hall, Shivaji University, Kolhapur**, as detailed below:

The provision of Section 30(4)(j) of Maharashtra Public Universities Act, 2016 is as under:

30(4)(j) two members elected by the Academic Council form amongst its members, one of whom shall be from amongst the elected teachers who are members of the Council and another shall be a woman;

The term of office of the elected members shall be as provided under Section 62 of the Maharashtra Public Universities Act, 2016.

Candidates shall submit their nominations for election in prescribed form alongwith the copies of required documents as per provision of Section 30(4)(j), eligibility conditions as prescribed in the official Gazette of Government of Maharashtra dated 29th April, 2017 and Receipt of prescribed nomination fee of Rs.100/- paid to in University office in person or through a person authorized by him in writing before **Monday, the 21st August, 2023 before 5.00 p.m.** at Inward Section at Room No.330 of the University office.

The list of members of the Academic Council is published on University Website www.unishivaji.ac.in in 'University Election 2022' portal.

The candidate must fill the nomination form which are made available at Shivaji University Central Co. Op. Consumers Stores Ltd. at prescribed fee of Rs.10/- The nomination forms shall contain date, name in full, address and designations, if any and electoral number of signatories and of the candidate nominated. The nomination form shall be dated and signed by two electors entitled to vote.

No person shall be nominated as a candidate for election unless he/she signifies his/her consent under his/her signature and date on the nomination paper. No person shall either propose or second his own nomination.

The eligibility conditions for being elected as prescribed in the official Gazette of Government of Maharashtra dated 29th April, 2017 is as follows:

Section 30(4)(j) ELECTED TEACHER MEMBER OF ACADEMIC COUNCIL.

- (a) Shall possess Ph.D. Degree,
- (b) Shall have at least 15 years aggregate teaching experience,
- (c) Shall be a recognised Ph.D. Guide under whose supervision, at least two students have been awarded Ph.D. Degree,
- (d) Shall have authored / co-authored at least two text books / reference books or shall have published at least three research papers in peer reviewed journals as first / corresponding author,
- (e) Shall have undertaken university examination related work for at least five years in aggregate.

A candidate contesting the election, shall submit his/her nomination alongwith necessary documents. The documents to be enclosed with nomination form are :

- i) Ph.D. degree certificate.
- ii) Experience certificate showing atleast 15 years teaching experience.
- iii) Letter of award of Ph.D. Degree to at least two students.
- iv) First page of at least two text books / reference books or published three research papers in peer reviewed journals.
- v) Certificate regarding university examination related worked at least five years.
- vi) Receipt of prescribed nomination fee of Rs.100/- paid to the University office.

Incomplete nomination form or the nomination form which does not comply with necessary documents shall be invalid and rejected. For further detailed information, please refer election and eligibility statutes which are available at

University Election 2022 portal of www.unishivaji.ac.in. The provisions in Act and Statute shall be final and binding.


The scrutiny of the nomination forms shall be done on **Monday, 21st August, 2023 at 5.30 p.m.** in the University Office. The candidate or his/her agent whose name has been included in the final electoral roll and duly authorised by him/her in writing in this behalf shall be entitled to be present at such scrutiny to be held at the University Office.

It shall be open to the candidate to withdraw his/her candidature from the election, provided that the candidate submits an application in person or through person authorized by him in writing for withdrawal **before 5.00 p.m. on Wednesday, the 23th August, 2023** in writing, signed by the candidate and duly attested by the Magistrate or the Principal of affiliated College or the Head of recognised Institute or the Head of the University Department to the undersigned. The list of the candidates validly nominated for the election will be notified on the notice board of the University Office and University Website www.unishivaji.ac.in soon after the expiry of the date of withdrawal of nomination.

In the case of elections, where there is a contest the ballot box will be kept open for the receipt of voting papers for **between 1.00 pm to 2.00 pm. on Saturday, 2nd September, 2023**. Members coming after the specified time will not receive voting papers. The counting of the said election will begin immediately after voting.

If the number of valid nominations does not exceed the number of vacancies to be filled, the candidates nominated shall be declared to have been elected in the meeting.
