Election of **One member of the Academic Council** on the State Board of the Maharashtra Secondary and Higher Secondary Education Board, Pune Division to be elected from the Academic Council.

In exercise of the powers conferred upon me under Sub-section 6 (d) of Section 14 of the Maharashtra Public Universities Act, 2016 and as provided in Election Statute under official Gazette of Government of Maharashtra dated 29th April, 2017, it is hereby notified for the information to all the members of the Academic Council concerned that the election of **One member of the Academic Council** on the Maharashtra Secondary and Higher Secondary Education Board, Pune Division will be held on **Saturday, the 2nd September, 2023**. The election shall be held by ballot at the Academic Council meeting.

The term of office of the elected member shall be as provided under Section 5 of the Maharashtra Secondary and Higher Secondary Education Boards Act 1965 until a person shall cease to hold office as a member of the State Board, if he ceases to belong to the Academic Council or the authority of the University the members of which elected him.

Candidates shall submit their nominations for election in prescribed form alongwith the copies of required documents in person or through a person authorized by him in writing before Monday the 21st August, 2023 before 5.00 p.m. at University office at Room No.330.

The candidate must fill the nomination form which are made available at Shivaji University Central Co. Op. Consumers Stores Ltd. at prescribed fee of Rs.10/- The nomination forms shall contain date, names in full, address and designations, if any, and electoral number of signatories and of the candidate nominated. The nomination form shall be dated and signed by two electors entitled to vote.

No person shall be nominated as a candidate for election unless he/she signifies his/her consent under his/her signature and date on the nomination paper. No person shall either propose or second his own nomination:

A candidate contesting the election, shall submit his/her nomination alongwith the following declaration:

DECLARATION OF THE CANDIDATE

- (1) I hereby declare on oath that the information given by me in the enclosed nomination form is true and correct and
- (2) that my candidature is governed by the provision of Section '9' Maharashtra Secondary and Higher Secondary Education Board, Pune Division Act 1965 which is reproduced below:

Section 9: Disqualification of Chairman and members.

A person shall be disqualified for being appointed, elected, nominated or designated as, or for continuing as, a Chairman or member of the State Board and of a Divisional Board or of any Committee appointed under the Act-

- (a) if he directly or indirectly, by himself or his partner, -
 - (i) has or had any share or interest in any text-book published, or
 - (ii) has any share or interest in any work done by order of, or in any contract entered into on behalf of the State Board or a Divisional Board:

Provided that, a person who had any share or interest in any textbook referred to in sub-clause, (i) shall not be deemed to have incurred the disqualification under that sub-clause, if five years have elapsed from the date of publication of such book;

(b) if he is a person against whom an order of removal from office has been made under sub-section (1) or sub-section (2) of section 15:

Provided that a person against whom such order is made shall not be deemed to be disqualified under this clause, if five years (or such lesser period as the State Government may specify) has clapsed from the date of his removal from office.

Explanation - for the purposes of sub-clause (i) of clause (a) -

- (A) the publication of a text-book shall include its republication;
- (B) a person shall be deemed to have incurred disqualification by reason of his having any share or interest in the business of the publisher of such text-book.

Signature of the Candidate

Incomplete nomination form or the nomination form which does not comply with all the requirements as mentioned above and the provisions in the Statute shall be invalid and shall be rejected. For further detailed information, please refer election and eligibility statutes which are available at University Election 2022 portal of www.unishivaji.ac.in regarding the procedure of election, the provisions in Act and Statute are final and binding.

The scrutiny of the nomination forms shall be done on Monday 21st August, 2023 at 5.30 p.m. in the University Office. The candidate or his/her agent whose name has been included in the final electoral roll and duly authorised by him/her in writing in this behalf shall be entitled to be present at such scrutiny to be held at the University Office.

It shall be open to the candidate to withdraw his/her candidature from the election, provided that the candidate submits an application in person or through person authorized by him in writing for withdrawal before 5.00 p.m. on Wednesday, the 23th August, 2023, in writing, signed by the candidate and duly attested by the Magistrate or the Principal of affiliated College or the Head of recgonised Institute or the Head of the University Department to the undersigned. The list of the candidates validly nominated for the election will be notified on the notice board of the University Office and University Website www.unishivaji.ac.in soon after the expiry of the date of withdrawal of nomination.

In the case of elections, of contesting post, the ballot box will be kept open for the receipt of voting papers between 1.00 pm to 2.00 pm. on Saturday, 2nd September, 2023. The members coming after the prescribed time will not receive voting papers.

The counting of the said elections will begin at 2.00 pm on the same day.
