NOTICE OF ELECTION

Election of **TWO TEACHERS**, representing each faculty, with not less than fifteen years of teaching experience to be elected by the collegiums of teachers (College Teachers and University Teachers) from amongst themselves out of whom one each shall be a person belonging Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jaties)/ Nomadic Tribes or Other Backward Class provided that the reservation per faculty shall be decided by drawing lots:

Provided that, out of the teachers representing each faculties, under this clause, one shall be a woman, to be decided by drawing lots.

The eligibility conditions for being elected as prescribed in the official Gazette of Government of Maharashtra dated 29th April, 2017 is as follows:

- (a) Shall possess Ph.D. Degree,
- (b) Shall have at least 15 years aggregate teaching experience,
- (c) Shall be a recognised Ph.D. Guide under whose supervision, at least two students have been awarded Ph.D. Degree,
- (d) Shall have authored / co-authored at least two text books / reference books or shall have published at least three research papers in peer reviewed journals as first / corresponding author,
- (e) Shall have undertaken university examination related work for at least five years in aggregate

The seats to be elected are distributed by drawing lots as mentioned in following table:

In exercise of the powers conferred upon me under Sub-section 6 (d) of Section 14 of the Maharashtra Public Universities Act, 2016 and as provided in Election Statute under official Gazette of Government of Maharashtra dated 29th April, 2017, it is hereby notified for the information to all the College and University Teachers concerned that the elections of **TWO TEACHERS representing each Faculty** will be held on **Friday, the 17th November, 2017**. The election shall be held by ballot at the Polling Centres. The separate voting paper will be given to each category. The list of Polling Centres where voters are required to go in person for voting, are available at University Election 2017 link of www.unishivaji.ac.in and notice board of the University.

The important dates for the present elections of Two Teachers from each faculty are as below:

The term of office of the elected members shall be as provided under Section 62 of the Maharashtra Public Universities Act, 2016.

Candidates shall submit their nominations for election in prescribed form alongwith the copies of required documents in person or through a person authorized by him in writing before **Tuesday the 31**st **October, 2017 before 5.00 p.m.** at University office at Room No.330.

The candidate must fill the nomination form which are made available at Shivaji University Central Co. Op. Consumers Stores Ltd. at prescribed fee of Rs.10/- The nomination forms shall contain date, names in full, address and designations, if any, and electoral number of signatories and of the candidate nominated. The nomination form shall be dated and signed by two electors entitled to vote.

No person shall be nominated as a candidate for election unless he/she signifies his/her consent under his/her signature and date on the nomination paper. No person shall either propose or second his own nomination:

Provided that, in case there are less than three voters, the candidate himself may propose and second his own nomination.

A candidate contesting the election, shall submit his/her nomination alongwith the following documents:

- (a) Self attested copy of Ph.D. Degree,
- (b) Experience Certificate of at least 15 years aggregate teaching experience,
- (c) Self attested copy of recognised Ph.D. Guide and declaration letters of Ph.D. of at least two students under his/her supervision.

- (d) Copies of authored / co-authored at least two text books / reference books or three research papers in peer reviewed journals as first / corresponding author,
- (e) Experience Certificate of having undertaken university examination related work for at least five years in aggregate.
- (f) Self attested copy of a caste certificate and Certificate of validity in support of their candidature from respective reserved category.
- (g) Receipt of prescribed nomination fee of Rs.100/- paid to the University office.

Incomplete nomination form or the nomination form which does not comply with all the requirements as mentioned above and the provisions in the Statute shall be invalid and shall be rejected. For further detailed information, please refer election and eligibility statutes which are available at University Election 2017 portal of www.unishivaji.ac.in. The provisions in Act and Statute are final and binding.

The scrutiny of the nomination forms shall be done on **Thursday** 2nd **November**, 2017 at 11.00 a.m. in the University Office. The candidate or his/her agent whose name has been included in the final electoral roll and duly authorised by him/her in writing in this behalf shall be entitled to be present at such scrutiny to be held at the University Office.

It shall be open to the candidate to withdraw his/her candidature from the election, provided that the candidate submits an application in person or through person authorized by him in writing for withdrawal before 5.00 p.m. on Saturday the 4th November, 2017, in writing, signed by the candidate and duly attested by the Magistrate or the Principal of affiliated College or the Head of recgonised Institute or the Head of the University Department to the undersigned. The list of the candidates validly nominated for the election will be notified on the notice board of the University Office and University Website www.unishivaji.ac.in soon after the expiry of the date of withdrawal of nomination.

The voting paper/papers will be issued to the voter at the respective polling centre on Friday, the 17th November, 2017 between 9.00 a.m. and 5.00 p.m. No voting paper shall be provided to the voter who comes after the prescribed time of voting. Voters shall sign the counter foil on receipt of voting paper.

The voter shall have to vote at the specified polling centre fixed by the University and not at any other polling centre.

The copies of Electoral Roll are available at University Election 2017 portal of www.unishivaji.ac.in. and hard copy will be made available by 'on demand print' after payment of fees Rs.2/- per page through Debit Card in the University office at Room No.107.
