### Sub: Election to the Senate from the Principals.

Preparation of Electoral roll as per Section 28 Sub-section (2)(o) of the Maharashtra Public Universities Act 2016.

Sir/Madam,

For the election to the Senate as provided under Section 28(2)(o) of the Maharashtra Public Universities Act 2016, the provisions regarding the representation of Principals on the Senate is as given below:

28(2)(o) ten Principals of affiliated, conducted, autonomous colleges which are accredited by National Assessment and Accreditation Council (NAAC) or National Board of Accreditation, (NBA), as the case may be, to be elected by the collegium of principals from amongst themselves; of whom one each shall be a person belonging to Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis) or Nomadic Tribes, Other Backward Classes, and one shall be a woman;".

> Qualification: Qualification as prescribed in the Gazette of Government of Maharashtra dated 29/4/2017 is as under -

Elected by the Collegium of Principals from amongst themselve -

- (a) Shall possess Ph.D. degree, unless appointed as a Principal before 13.10.2000.
- (b) Shall be a Principal of a College which has valid Certification of Accreditation by National Assessment and Accreditation Council or National Board of Accreditation as the case may be and period of validity of such Certificate is unexpired.

(c) Shall have undertaken university examination related work for at least five years in aggregate.

In accordance with the above mentioned provisions, electoral roll of the Principals of the affiliated, conducted and autonomous colleges is to be prepared and published for election to the Senate.

I am, therefore, to request you to send the name/s of the Principals of the college/s run by your Sanstha alongwith the photocopies of their Appointment Order/s and the University Approval letter/s so as to reach this office on or before 30th June, 2017. It will be helpful if you can specify the faculty under which the name of the Principal/s is to be included so as to avoid further correspondence.

As per Section 2(44) of the said Act, the definition of "Principal" is reproduced below for your information and ready reference.

2 (44) "Principal" means a teacher who is duly approved as a Principal by the university"

You are requested to look personally into this matter and see that the information alongwith the necessary documents are sent, so as to reach this office on or before 30th June, 2017.
