**Sub: Election to the Senate from the Representatives of the
Managements.**

Preparation of Electoral roll as per Section 28 Sub-section (2)(p)
of the Maharashtra Public Universities Act 2016.

Sir/Madam,

The election to the Senate as provided under Section 28(2)(p) of the Maharashtra Public Universities Act, 2016 is to be conducted in near future, according to the schedule declared soon. The provisions regarding the Representatives of the Managements on the Senate is as given below :

28(2)(p) six representatives of Management - to be elected from among the collegium of management representatives of the affiliated colleges or institutions out of whom one shall be from Scheduled Castes or Scheduled Tribes or Denotified Tribes (*Vimukta Jatis*) or Nomadic Tribes or Other Backward Classes category, by rotation, and one shall be woman :

Provided that, such representatives of management to be elected shall be the representatives of management of colleges which are accredited by National Assessment and Accreditation Council or National Board of Accreditation as the case may be :

Provided further that, where a management conducts one or more Colleges or Institutions, only one representative of such management shall be eligible for being included in collegium of Management Representatives;

Explanation : 2(37) "management" means the trustees or the managing or governing body, by whatever name called, of any trust registered under the Maharashtra Public Trusts Act, or any society registered under the Societies Registration Act, 1860 or a Company registered under section 8 of the Companies Act, 2013, under the management of which one or more colleges or recognized institutions or other institutions of higher learning, are conducted and admitted to the privileges of the university:

Provided that, in relation to any college or institution established or maintained by the Central Government or the State Government or a local authority like a Zilla Parishad, Municipal Council or Municipal Corporation, it means, respectively, the Central Government or the State Government or Zilla Parishad or the Municipal Council or the Municipal Corporation, as the case may be;

Qualification: Qualification as prescribed in the Gazette of Government of Maharashtra dated 29/4/2017 is as under -

Elected by the Collegium of Management Representatives of the Affiliated Colleges or Institutions from amongst themselves -

- (a) Shall possess Bachelors Degree,
- (b) Shall be a member of Governing Body/ Management Committee of the Management for at least two years,
- (c) Shall have at least one College or Institution run by such Management having valid Certification of Accreditation by National Assessment and Accreditation Council or National Board of Accreditation, as the case may be and period of validity of such Certificate is unexpired.

In accordance with the above mentioned provisions, electoral roll of the Representatives of the Managements of the affiliated colleges/reognized institution, conducted and autonomous colleges is to be prepared and published for election to the Senate.

I am, therefore, to request you to send the name/s of the Chairman/President or the representative of the Management so as to include his name in the electoral roll. Alongwith this information, a copy of the resolution passed by the Management stating that "The said person will represent the management for the purpose of electoral roll" must also be sent.

You are requested to look personally into this matter and see that the information alongwith the necessary documents are sent, as to reach this office on or before 30th June, 2017.
