The said applications were scrutinized by the Election Officer on declared date i.e. 2nd November 2017. Few candidates has withdrawn their candidature from the election and the decision on appeals challenging the decision of scrutiny is given by appellate authority Vice Chancellor of the Shivaji University, Kolhapur.

In pursuance the decision of Scrutiny, withdrawal of nominations and decisions on the appeals by the Vice Chancellor, I hereby notify the names of the Valid Nominations contesting the elections for these elections of **teachers**.

The provision in the Uniform Statute No. 1 of 2017 published in Gazette of Maharashtra published on 17th May 2017, regarding Election of University Authorities at No. 10(8) following is the Provision :

10(8) If the number of valid nominations does not exceed the number of vacancies to be filled, the candidates nominated shall be declared to have been elected on the date of declaration of result of election.

It should be noted by the concerned as per the provision mentioned above there will not be voting for those constituencies and categories of the **teachers** where the number of vacancies are equal or less than number of candidates.

Also, as per the program of Election declared on 15th Sept. 2017 and Notice of the Election dated 22nd October 2017, voting for those categories where number of candidates are more than the vacancies is scheduled on 17th November 2017 at pre-declared centers.
