**NOTICE OF ELECTION**

In exercise of the powers conferred upon me under Sub-section 6 (d) of Section 14 of the Maharashtra Public Universities Act, 2016 and as provided in Election Statute under official Gazette of Government of Maharashtra dated 29<sup>th</sup> April, 2017 it is hereby informed by this notification to all the members of the Senate that the elections as stated above to the Management Council under Section 30(4) of the Maharashtra Public Universities Act 2016 shall be held by ballot at the Senate meeting to be held on **Monday 26<sup>th</sup> February, 2018** in the University Office, at Vidyanagar, Kolhapur.

The seats to be elected are distributed by drawing lots on 01/02/2018 at 11.30 am by Hon'ble Vice Chancellor of Shivaji University and seats to be elected are as mentioned in following table.

**Election to the Management Council:**

**30 (4) (f) Two Principals :** to be elected by the Senate from amongst the principals who are the members of the Senate, One shall be a Open category and as per drawing lots, one shall be De-notified Tribes (*Vimukta Jatis*) category.

The eligibility conditions for being elected as prescribed in the official Gazette of Government of Maharashtra dated 29<sup>th</sup> April, 2017 is as follows:

- (a) Shall possess Ph.D. degree, unless appointed as a Principal before 13.10.2000.
- (b) Shall have undertaken university examination related work for at least five years in aggregate.

A candidate contesting the election, shall submit his/her nomination alongwith the following documents:

- a) Self attested copy of Ph.D. Degree (unless appointed as Principal before 13.10.2000)
- b) Self attested copy of a caste certificate in support of their candidature from respective reserved category.
- c) Receipt of prescribed nomination fee of Rs.100/- paid to the University office.

**30 (4) (g) Two Teachers :** to be elected by the Senate from amongst the Teachers who are the members of the Senate, One shall be a Open category and as per drawing lots, one shall be Other Backward Class category.

The eligibility conditions for being elected as prescribed in the official Gazette of Government of Maharashtra dated 29<sup>th</sup> April, 2017 is as follows:

- (a) Shall possess Ph.D. Degree with at least ten years teaching experience in aggregate or shall have at least Fifteen years teaching experience in aggregate.
- (b) Shall have undertaken university examination related work for at least five years in aggregate.

A candidate contesting the election, shall submit his/her nomination alongwith the following documents:

- a) Self attested copy of Ph.D. Degree. (if applicable)
- b) Self attested copy of Experience Certificate of Teaching.
- c) Self attested copy of Certificate / Proof regarding having undertaken Examinations work for at least 5 years.
- d) Self attested copy of a caste certificate in support of their candidature from respective reserved category.
- e) Receipt of prescribed nomination fee of Rs.100/- paid to the University office.

**30 (4) (h) Two Representatives of Managements :** to be elected by the Senate from amongst the Representatives of Managements who are the members of the Senate, One shall be a Open category and as per drawing lots, one shall be Scheduled Castes category.

The eligibility conditions for being elected as prescribed in the official Gazette of Government of Maharashtra dated 29<sup>th</sup> April, 2017 is as follows:

- (a) Shall possess Bachelors Degree,
- (b) Shall be a member of Governing Body/ Management Committee of the Management for at least two years,

- (c) Shall have at least one College or Institution run by such Management having valid Certification of Accreditation by National Assessment and Accreditation Council or National Board of Accreditation, as the case may be and period of validity of such Certificate is unexpired.
- (d) Who is not the Representative of such Management which had its Management Representative on the immediately preceding Management Council of the University.

A candidate contesting the election, shall submit his/her nomination alongwith the following documents:

- (a) Self attested copy of Bachelors Degree,
- (b) Self attested copy of a membership of Governing Body/ Management Committee of the Management for at least two years,
- (c) Self attested copy of certificate of at least one College or Institution run by such Management having valid Certification of Accreditation by National Assessment and Accreditation Council or National Board of Accreditation, as the case may be and period of validity of such certificate is unexpired.
- (d) Self attested copy of a caste certificate in support of their candidature from respective reserved category.
- (e) Receipt of prescribed nomination fee of Rs.100/- paid to the University office.

**30 (4) (i) Two Registered Graduates :** to be elected by the Senate from amongst the Registered Graduates who are the members of the Senate, One shall be a Open category and as per drawing lots, one shall be Scheduled Tribes category.

The eligibility conditions for being elected as prescribed in the official Gazette of Government of Maharashtra dated 29<sup>th</sup> April, 2017 is as follows:

- Elected by the Senate from amongst elected Registered Graduate Members of the Senate.

A candidate contesting the election, shall submit his/her nomination alongwith the following documents:

- (a) Self attested copy of Degree certificate.
- (b) Self attested copy of a caste certificate in support of their candidature from respective reserved category.
- (c) Receipt of prescribed nomination fee of Rs.100/- paid to the University office.

The term of office of the elected members shall be as provided under Section 62 of the Maharashtra Public Universities Act, 2016.

Candidates shall submit their nominations for election in prescribed form alongwith the copies of required documents in person or through a person authorized by him in writing before **Thursday the 15<sup>th</sup> February, 2018 before 5.00 p.m.** at Inward Section at Room No.138, of the University office.

The candidate must fill the nomination form which are made available at Shivaji University Central Co. Op. Consumers Stores Ltd. at prescribed fee of Rs.10/- The nomination forms shall contain date, names in full, address and designations, if any, and electoral number of signatories and of the candidate nominated. The nomination form shall be dated and signed by two electors entitled to vote.

No person shall be nominated as a candidate for election unless he/she signifies his/her consent under his/her signature and date on the nomination paper. No person shall either propose or second his own nomination:

A candidate contesting the election, shall submit his/her nomination alongwith the necessary documents.

Incomplete nomination form or the nomination form which does not comply with all the requirements as mentioned above and as provided in the Statute shall be invalid and shall be rejected. For further detailed information, please refer election and eligibility statutes which are available at University Election 2017 portal of [www.unishivaji.ac.in](http://www.unishivaji.ac.in). The provisions in Act and Statute are final and binding.

The scrutiny of the nomination forms shall be done on **Saturday 17<sup>th</sup> February, 2018 at 3.00 p.m.** in the University Office. The candidate or his/her agent whose name has been included in the final electoral roll and duly authorised by him/her in writing in this behalf shall be entitled to be present at such scrutiny to be held at the University Office.

It shall be open to the candidate to withdraw his/her candidature from the election, provided that the candidate submits an application in person or through person authorized by him in writing for withdrawal **before 5.00 p.m. on Monday the 19<sup>th</sup> February, 2018**, signed by the candidate and duly attested by the Magistrate or the Principal of affiliated College or the Head of recognised Institute or the Head of the University Department to the undersigned. The list of the candidates validly nominated for the election will be notified on the notice board of the University Office and University Website [www.unishivaji.ac.in](http://www.unishivaji.ac.in) soon after the expiry of the date of withdrawal of nomination.

In the case of elections, of contesting post, the **ballot box will be kept** open for the receipt of voting papers **between 1.00 pm to 2.00 pm. on Monday 26<sup>th</sup> February, 2018**. The members coming after the specified time will not receive voting papers.

The counting of the said elections will begin at 3.00 pm on the same day.
