Order

Whereas the Maharashtra Public Universities Act, 2016 (Maharashtra Act No.VI of 2017) (here in referred to as "Said Act") has come into force from 1st March, 2017.

And

Whereas Section 34(2) of the said Act, provides faculties of the University.

And

Whereas Facultywise inclusion of Degrees. as per Section 34(2) of Maharashtra Public Universities Act, 2016 are not prescribed by Statute. Earlier statutes framed under Maharashtra Universities Act, 1994 prescribing Degrees under these faculties are inconsistent with provisions in the Maharashtra Public Universities Act, 2016.

And

Whereas the Statute 548 prescribing the faculty wise Degrees under the Maharashtra Universities Act, 1994 are deemed to be repealed.

And

Whereas therefore the matter is required to be regulated by the Statutes and in the absence of the same for the time being issuance of the directions by the Vice-Chancellor u/s 12(8) of Maharashtra Public Universities Act, 2016 is necessary.

And

Whereas the new Statute prescribing faculty wise merging / inclusion of Degrees to respective faculties under Maharashtra Public Universities Act, 2016 is not yet made hence the matter was provisionally regulated by issuing order Ref : SU/ BOS/ 28 Date : 15/01/2025

And

Whereas, previous order Ref : SU/ BOS/ 28 Date : 15/01/2025 has automatically lapsed therefore this order needs to be issued and notified u/s12(8) of the Maharashtra Public Universities Act, 2016. effective from the date 16/07/2025.

Therefore, I Prof. Dr. Suresh Gosavi, I/c Vice-Chancellor, Shivaji University, Kolhapur hereby regulate the matter by issuing following directions in exercise of powers conferred on me u/s12(8) of Maharashtra Public Universities Act, 2016.
