## Title of the Paper: Applied Linguistics and Second Language Teaching

## (i) Specific Objectives:

The objective of the course is to offer a foundation in approaches and techniques for the teaching of second or foreign languages from the perspective of Applied Linguistics. It aims to train participants to know how to use research in Applied Linguistics and Second Language Acquisition (SLA) in language teaching practice.

The course aims to provide an overview of selected areas of current second language acquisition research; an introduction to some contemporary language teaching approaches and their underlying principles.
