#### Relevance of the course

- This course is designed as recommended in UGC's SAKSHAM Report about measures for ensuring safety of women and programmes for gender sensitization.
- Shivaji University has committed itself to the implementation of UGC's SAKSHAM Report.
- The Course is designed for developing an understanding about gender inequalities and their adverse effects on women as well as men.
- It aims at sensitising students and employees of Shivaji University about integrating gender sensitive practices in their private and professional life.

#### **Course Structure:**

- Weightage Two Credits; Duration 30 hours; one semester. (May be taught over two weekends)
- Theory examination- 90 minutes duration, maximum 40 marks.
- Internal assessment- Assignments/ Seminars/ Fieldwork maximum 10 marks.

#### **Admission:**

- 1. Admission is open to any graduate.
- 2. SUK employees may undergo this course as part of in-service training.
- **3.** At least 75% attendance is required to enable to student to appear for theory examination.
- **4.** Maximum intake for the course is 25.

#### Fee

Tuition as well as examination fee is included in the fee for candidates' respective programmes.
