

- 1) While indicating the make of a product, the name of the manufacturer may be specified to enable us to consider your offer and expedite orders. Supplies are to be made in the manufacturer's pickings only; your quotation should accordingly be adjusted to the nearest size of the original packing of the manufacturers.
- 2) The price quoted may be as indicated below in clause (a) for Outstation firms and (b) for local firms.
 - a) F.O.R. Destination/dispatching station by goods/passenger train.
 - b) For free delivery at the **School of Nanoscience and Biotechnology, Shivaji University Kolhapur 416004.**
- 3) Your rates are assumed to include packing and forwarding charges unless separately stated. The goods should be insured against theft, loss, or breakage during transit and insurance charges should not exceed 3% of the cost of materials supplied.
- 4) The rate of sales Tax, GST, CST, and excise duty may be indicated wherever chargeable, in the absence of which it will be deemed that no taxes are payable by us.
